BE IT ORDAINED BY THE BOARD OF COUNCIL

OF THE CITY OF LAWRENCEBURG, KENTUCKY, as follows:

Section 1. That the City of Lawrenceburg hereby annexes to the City boundary a certain tract of land lying and being on the northeasterly side of U.S. Bypass 127 and the northerly side of Carlton Drive containing 22.52 acres, more or less.

Section 2. That the tract of real property to be annexed is more particularly described as follows:

A description for annexation all of that land included in the Overland Shopping Center (Plat Cabinet "A," Slide 7) U.S. By Pass 127/Carlton Drive; the properties of Lawrenceburg/Anderson County (DB. 103, PG. 070); Forest Hill, Inc. (DB. 166, PG. 692); The Overland Church of Christ (DB. 178, PG 676/DB. 094, PG 023); Bowles and Grant, L.L.C., DB. 175, PG. 581

Said tract of land lying and being in Anderson County, Kentucky, on the northeasterly side of U.S. By Pass 127 and the northerly side of Carlton Drive and being more fully described as follows:

Beginning at the northerly intersection of right-of-ways of U.S. By Pass 127 and Carlton Drive at the southwesterly corner of the Bowles and Grant, L.L.C. property (DB. 175, PG. 581), thence with the right-of-way of By Pass 127 N 22°28′28" W 77.77' thence N 23°54′ 33" W 498.99' thence N 24° 53′38" W 360.05' thence N

(DB. 175, PG. 581) and continuing with DHM, L.L.C., Mark Todd Hyatt S 38°36'58" E 1092.41' to the right of way of Carlton Drive, thence with the right-of-way S $51^{\circ}36'14$ " W 626.44' thence N $39^{\circ}28'01$ " W 10.36' thence S $50^{\circ}45'45$ " W 107.25' to the point of beginning containing 22.52 acres.

Section 3. That the tract of real property is adjacent to the City of Lawrenceburg, urban in nature, and it is desirable for the City to annex such tract.

Section 4. That following a public hearing and the recommendation of the Lawrenceburg/Anderson County Planning and Zoning Commission pursuant to KRS Chapter 100, the zoning for such annexed tract shall be as determined by the Commission.

Section 5. This Ordinance shall become effective upon its passage, approval, and publication as required by law.
