## ORDINANCE

## RELATING TO THE ANNEXATION OF LAND OR TERRITORY TO THE CITY OF LAWRENCEBURG, KENTUCKY

198 - 8

WHEREAS, an Ordinance declaring the intent to annex the hereinafter described property, was duly enacted by the Board of Council of the City of Lawrence-burg, on the 5th day of October, 1981; and

WHEREAS, a true and exact copy of said Ordinance was published in the October 15th, 1981, edition of The Anderson News, which Ordinance gave notice pursuant to KRS 81A.420, of the intent of said Council to enact an Ordinance annexing the subject real estate into the City of Lawrenceburg; and

WHEREAS, the Lawrenceburg-Anderson County Joint Planning Commission, has recommended the annexation, and recommended that the property be described and zoned as B-1 (Local Business); and

PHEREAS, the owners of said property desire the annexation, and whereas it is the finding of the City Council that such annexation will be desirable and that such annexation and zone classification will be beneficial to the citizens and property owners of the City of Lawrenceburg, and to the City of Lawrenceburg; and

WHEREAS, following the publication of the Ordinance declaring the intent to annex the hereinafter described property, no petition has been received

by the Mayor, as set out in KRS 81A.420; and

MOW. THEREFORE, be it

convened in session on the 28 May of DEcember 1981, as follows:

(1) That pursuant to KRS 81A.420, and all other applicable law, the territory hereinafter described shall be, and is hereby, a part of the City of Lawrenceburg, Kentucky, and is annexed into the City of Lawrenceburg, Kentucky, said property this day annexed, being a certain tract of real estate, lying and being on the east side of U.S. Highway 127 By-Pass and on the western limits of the City of Lawrenceburg, in Anderson County, Kentucky, and more particularly bounded and described, as follows:

Beginning at a point in the line of Richard Case and Arthur Green, which point is in the presently existing western boundary of the City of Lawrenceburg, and South 41 degrees 34 minutes 38 seconds East for a distance of 150 feet from the corner of U.S. Highway 62, Arthur Green, and Richard Case; thence with the line of Green and Case South 41 degrees 34 minutes 38 seconds East for a distance of 181.96 feet to an iron pin by a post in the line of the American Legion, Post 34; thence South 48 degrees 06 minutes 54 seconds West for a distance of 151.61 feet to an iron pin by a post; thence continuing with remaining lands of American Legion, Post 34, South 53 degrees 15 minutes 47 seconds East for a distance of 624.83 feet to an iron pin by a post corner to American Legion, Post 34, and the remaining lands of Richard Case; thence South 50 degrees 17 minutes 38 seconds West for a distance of 725.36 feet to an iron pin in the eastern right-of-way of U.S. Highway 127 By-Pass; thence with said eastern right-of-way of U.S. Highway 127 By-Pass North 24 degrees 36 minutes 23 seconds West for a distance of 98.08 feet to a brace post in said right-of-way line; thence with said right-of-way North 23 degrees 35 minutes 45 seconds West for a distance of approximately 721.64 feet to a point in the presently existing boundaries of the City limits of the City of Lawrenceburg; thence continuing in a northeasterly direction with the presently

existing boundaries of the City of Lawrenceburg to the point of beginning, according to a survey prepared by Garland S. Armstrong, Registered Land Surveyor, No. 329, on September 4th, 1981.

- (2) That said territory, above described, shall be zoned as B-1 (Local Business).
- City of Lawrenceburg shall cause an accurate map of the annexed area, together with a metes and bounds description, together with a true and accurate copy of this Ordinance, duly certified, to be recorded in the Office of the Clerk of the Anderson County, and in the Office of the Secretary of State for the Commonwealth of Kentucky.
- City of Lawrenceburg shall cause a map, clearly delineating the boundaries of the area affected, along with a list of the names and addresses of those property owners and/or registered voters who reside in such area, to be filed in the Office of the Anderson County Clerk. The Mayor of the City of Lawrenceburg is further authorized and directed to cause the advertisement and publication of this Ordinance, pursuant to law, in The Anderson News, a newspaper of general publication within the area to be annexed.
