



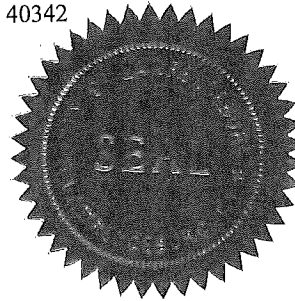

SECTION TWO

AN ORDINANCE
RELATING TO THE ANNEXATION OF
A TRACT OF LAND OR TERRITORY
TO THE CITY OF LAWRENCEBURG
KENTUCKY, WHICH ANNEXATION
WAS APPROVED BY JUDGMENT OF
THE ANDERSON CIRCUIT COURT

1972-6

WHEREAS, the territory described below was annexed to the City of Lawrenceburg by judgment of the Anderson Circuit Court, in Civil Action No. 1349, dated November 27, 1972:

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNCIL OF THE CITY OF LAWRENCEBURG, convened in regular session on the 4th day of December, 1972, as follows:

SECTION ONE

That said territory hereinafter described be, and the same is hereby annexed to and shall hereafter be a part of and within the limits of the City of Lawrenceburg, pursuant to judgment of the Anderson Circuit Court, aforementioned, which tract is more particularly described and bounded, as follows:

Beginning at a stake in the south right of way line

of U. S. Highway 62, at the northwest corner of territory annexed to the City of Lawrenceburg, by Ordinance Number 1970-4, (approved by Judgment of the Anderson Circuit Court, in Civil Action #1155, on November 23, 1970), thence with the western boundary of said territory, aforementioned, South 42 degrees 34 minutes 02 seconds East 545.90 feet to a stake in the west right of way line

of U. S. Highway 127 By-Pass, thence with said west right of way line of U. S. Highway 127 By-Pass, South 24 degrees 10 minutes 10 seconds East 674.24 feet to a post at the northeast corner of Ross, thence with the line of Ross, South 51 degrees 22 minutes 20 seconds West 452.22 feet to a post corner to Rogers, thence with the line of Rogers, North 42 degrees 03 minutes 10 seconds West 1,206.85 feet to a post in the south right of way line of said U. S. Highway 62, thence with said right of way line for three calls, as follows: North 48 degrees 22 minutes 45 seconds East 169.39 feet to a pin, South 41 degrees 13 minutes 0 seconds East 20 feet to a pin, and North 48 degrees 47 minutes 0 seconds East 182.30 feet to the point of beginning, containing 8.341 acres, according to survey made by D. L. Reeves, Registered Land Surveyor #633, on April 2, 1972, be the same more or less.

SECTION TWO

That upon the request of the owners of the above described property, (as well as the owners of property annexed by Ordinance 1970-4. Codified as Section I 28 of the Code of Ordinances of the City of Lawrenceburg), and the Board of Council being fully advised, it is now ordered and ordained that the above described real estate (as well as the property annexed by Ordinance 1970-4, aforementioned), be classified and zoned as LOCAL BUSINESS, B-1, in conformity with the zoned area located adjacent to and east of the above described properties.

SECTION THREE

This Ordinance shall be in full force and effect from and after its passage, approval attestation and publication, as required by law.
