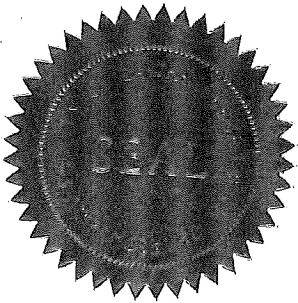



**AN ORDINANCE ANNEXING TO THE CITY OF
LAWRENCEBURG, KENTUCKY CERTAIN UNINCORPORATED
TERRITORY WITHIN THE COUNTY OF ANDERSON AND
WHICH ADJOINS THE PRESENT BOUNDARY LINE OF THE
CITY OF LAWRENCEBURG**

WHEREAS, Joseph N. Lococo and Norma J. Lococo have requested that the City of Lawrenceburg annex certain real property commonly known as the "Lococo Property" and as the owners of said property have provided their consent pursuant to KRS 81A.412. (A copy of said consent is attached hereto as Exhibit "A"), and

WHEREAS, the City Council of Lawrenceburg, Kentucky has deemed it appropriate and proper to annex that certain unincorporated are of the County of Anderson, more fully described herein and that such annexation will inure to the benefit of the present citizens of Lawrenceburg, Kentucky, and

WHEREAS, the unincorporated area to annexed meets the requirements set forth in KRS 81A.140 and all other requirements of the Kentucky Revised Statutes;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNCIL OF THE CITY OF LAWRENCEBURG, convened in regular secession in the 13th day of October, 2008 as follows:

Section 1: That the City Council for Lawrenceburg, Kentucky hereby finds that the area proposed for annexation is:

- a) presently adjacent or contiguous to the boundaries of the City and was so at the time the annexation proceedings began;
- b) suitable for development for urban purposes without unreasonable delay.

Section 2: That all of the Fee Simple owners of the territory to be annexed have provided the City with their written consent to the proposed annexation and have waived all rights set forth in KRS 81A.412, KRS 81A.420, and KRS 81A.425 and that such written consent is attached hereto as Exhibit "A."

Section 3: That the City Council for Lawrenceburg, Kentucky hereby annexes that certain territory within the County of Anderson which adjoins the present boundary of the City of Lawrenceburg and which is commonly known as Lococo Property. A further description and map of such annexed territory are attached hereto as Exhibit "B" and Exhibit "C" and are made fully apart hereof for all purposes.

Section 4: That the territory annexed hereby and described herein is presently zoned A-1 (Agriculture-1) under the ordinances, rules and regulation of the Lawrenceburg/Anderson County Planning and Zoning Commission.

Section 5: That upon the enactment of this Ordinance, the territory described herein shall be a part of the City of Lawrenceburg for all purposes.


Section 6: This Ordinance shall be in full force and effect from and after its adoption and publication, as required by law.





3. That the above described property is not included in the boundaries of another incorporated city.



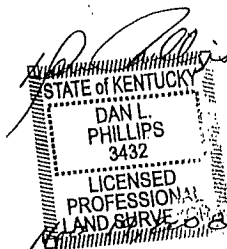

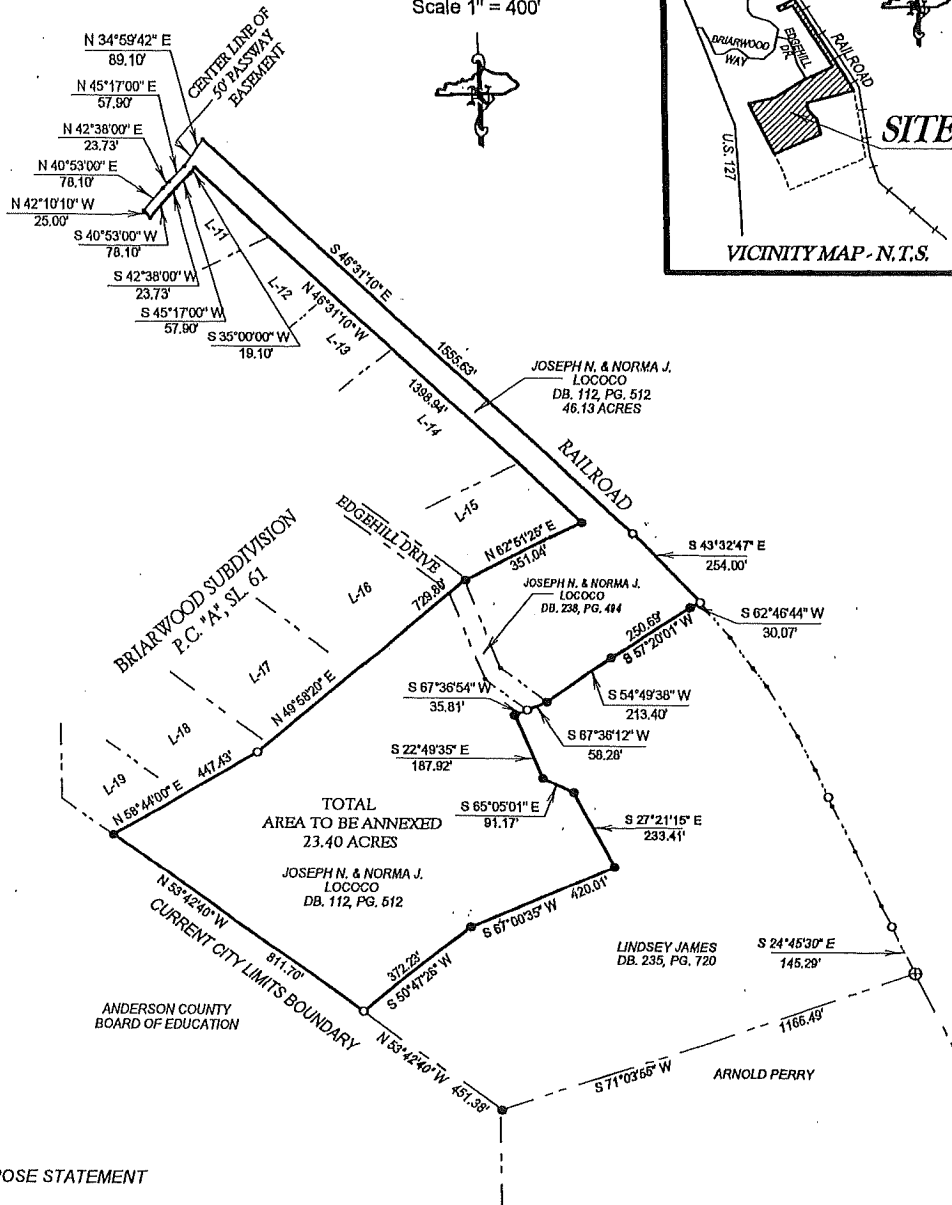
