AN ORDINANCE RELATING TO ANNEXATION OF LAND OR TERRITORY TO THE CITY OF LAWRENCEBURG, KENTUCKY

1978-10

WHEREAS, request has been made by all the property owners of the tract of land or territory hereinafter described that same be annexed to and made a part of the City of Lawrenceburg; and

WHEREAS, the Lawrenceburg-Anderson
County, Kentucky, Joint Planning Commission, following the
deliberation and study, recommends the proposed annexation, and
further recommends that the hereinafter described property bezoned as R-2 (Medium Density Residential); and

WHEREAS, because of the nature of such territory and its use and desirability as a medium density residential district, it is believed that such annexation will be beneficial to the said citizens and property owners, and to the City of Lawrenceburg;

NOW, THEREFORE, be it ordained by the Board of Council of the City of Lawrenceburg, Kentucky, convened in regular session on September 5, 1978, as follows:

SECTION 1

That Ordinance Number 1978-5, which Ordinance is duly recorded in City Ordinance Book 2, Page 483, be and the same, is hereby repealed and held for naught.
