ORDINANCE

AN ORDINANCE RELATING TO THE ANNEXATION
OF UNINCORPORATED AREAS TO THE CORPORATE
LIMITS OF THE CITY OF LEITCHFIELD, KENTUCKY


WHEREAS, The City of Leitchfield is a municipal corporation of the fourth class of the Commonwealth of Kentucky; and

WHEREAS, an ordinance declaring the intention of this City to annex the hereinafter described property has heretofore been adopted by the City Council of The City of Leitchfield, Kentucky, on January 4, 1988; and


WHEREAS, there has been no remonstrance following publication of the initial annexation ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF LEITCHFIELD, KENTUCKY, that the said City does hereby annex the real property described in Exhibit A, which is attached hereto and incorporated herein by reference.

DULY ADOPTED by unanimous vote of the City Council of The City of Leitchfield after first having been read on March 21, 1988, on this the ^{4th} day of April, 1988.

Survey Description: PROPOSED ANNEXATION, CITY OF LEITCHFIELD, KENTUCKY

BEGINNING at a steel pipe in the south right of way of the Old Leitchfield- Elizabethtown Pike, said point being in the existing Corporate Limit line in the north line of Baillee Lumber property and at the east line of Tell City Chair Co; thence along the existing Corporate Limit line with the north line of Baillee Lumber North $66^{\circ} 59' 07''$ East (original call of North $63^{\circ} 58'$ East), 876.96 feet to a steel rod with aluminum cap; thence leaving Baillee Lumber and the existing Corporate Limits, crossing the Old Leitchfield- Elizabethtown Pike and with an existing fence line at the east side of the Carroll Gibson driveway as follows:

North $36^{\circ} 44' 41''$ West, 702.78 feet to a steel post;

North $33^{\circ} 56' 04''$ West, 61.99 feet to a steel post;

North $21^{\circ} 36' 17''$ West, 73.18 feet to a steel post and

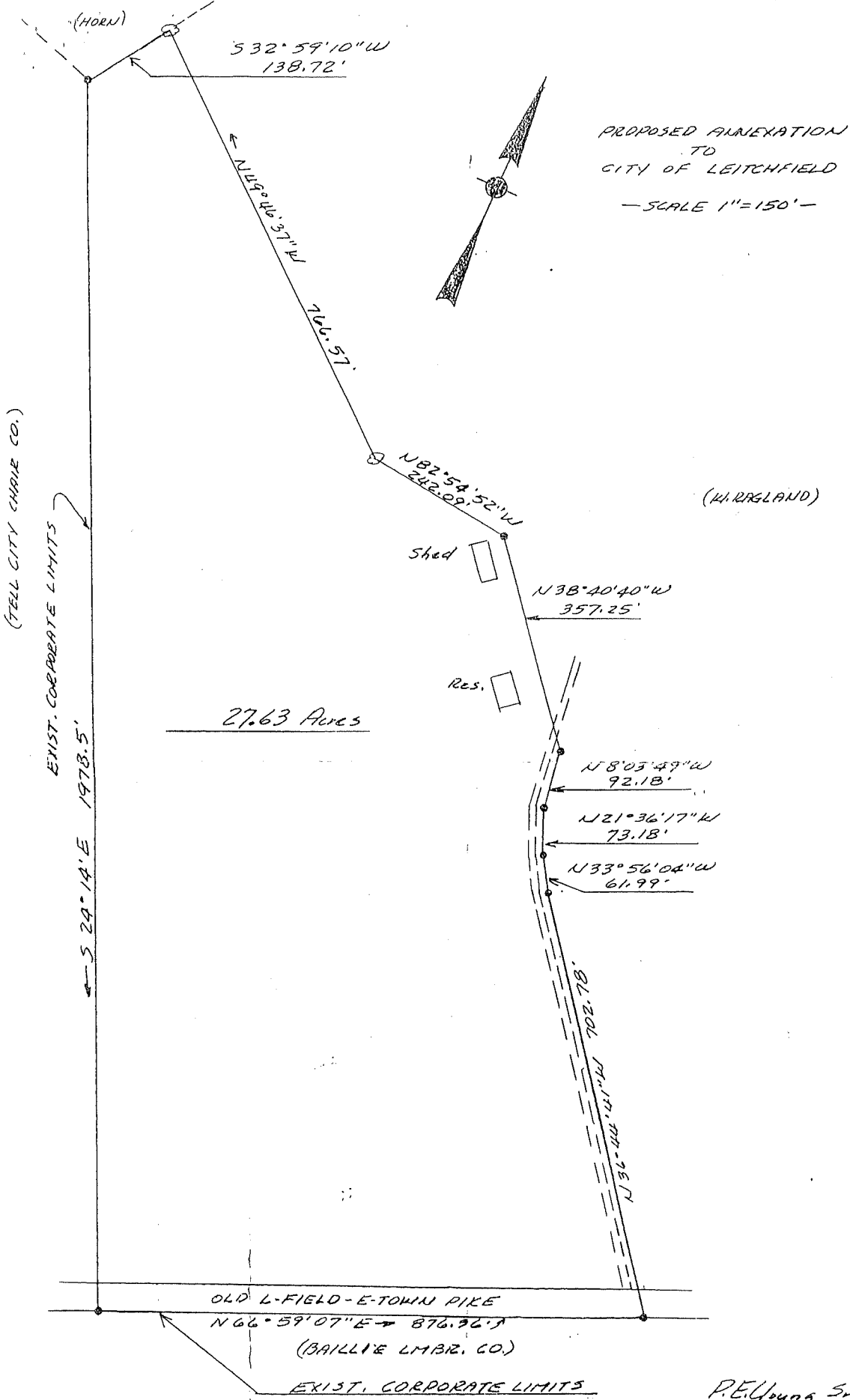
North $8^{\circ} 03' 49''$ West, 92.18 feet to a steel post; thence leaving the fence line and with a line to the east of the Carroll Gibson residence North $38^{\circ} 40' 40''$ West, 357.25 feet to a wooden fence post at the northeast corner of a tool shed; thence North $82^{\circ} 54' 52''$ West, crossing a pond, 242.09 feet to a large sassafras; thence, with a fence line, North $49^{\circ} 46' 37''$ West, 766.57 feet to a dead wild cherry in the line of Horn; thence with Horn South $32^{\circ} 59' 10''$ West, 138.72 feet to a steel post in the line of Tell City Chair Co. and the existing Corporate Limits; thence with Tell City Chair Co. and the existing Corporate Limits South $24^{\circ} 14'$ East (original call of South $23^{\circ} 20'$ East) crossing the Old Leitchfield- Elizabethtown Pike, a total distance of 1978.5 feet to the point of beginning, containing 27.63 acres.
