AN ORDINANCE RELATING TO THE ANNEXATION OF
UNINCORPORATED AREAS TO THE CORPORATE
LIMITS OF THE CITY OF LEITCHFIELD, KENTUCKY

WHEREAS, The City of Leitchfield is a municipal corporation of the fourth class of the Commonwealth of Kentucky; and

WHEREAS, such cities may annex unincorporated territory pursuant to Chapter 81A of the Kentucky Revised Statutes; and

WHEREAS, an ordinance declaring the intention of this City to annex the hereinafter described property has heretofore been adopted by the City Council of The City of Leitchfield, Kentucky, on April 6, 1987; and

WHEREAS, there has been no remonstrance within sixty (60) days following the publication of the initial annexation ordinance;


NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF LEITCHFIELD, KENTUCKY, THAT THE CITY OF LEITCHFIELD, KENTUCKY, DOES HEREBY ANNEX THE FOLLOWING DESCRIBED PROPERTY WHICH IS CONTIGUOUS TO THE EXISTING CORPORATE LIMITS OF THE CITY, TO-WIT:

A certain tract or parcel of property lying adjacent to the west city limits of Leitchfield, Kentucky, and to the north of the south right of way line of Kentucky Highway No. 54 and more particularly described as follows:

BEGINNING at a stake in the present city limits of Leitchfield in the south right of way line of Kentucky Highway No. 54; said beginning being N 3 degrees 00' E 60 feet from a boundary marker in the north lines of the Old Hartford Road and approximately 80 feet west of the Old Hartford Roads intersection with Kentucky Highway No. 54; thence with the south right of way of Kentucky Highway No. 54, S 79 degrees 28' W 1385.10 feet to a stake; thence crossing Kentucky Highway No. 54 and with an old fence line (the west line of Clayton Watkins Const. Co. and the east line of the Faye Kinser tract) N 10 degrees 47' W 1504.36 feet to a stone at a fence corner in the Margaret Anderson tract; thence with ~~the~~ south line of Anderson, the north lines of Watkins and Shartzler and continuing until crossing the southeast corner of the Anderson tract N 80 degrees 41' E 1745.04'

feet to a point near a sinkhole in the Anderson tract at the rear of the B.W. Lyons residence in the existing west city limits of Leitchfield; thence with the city limits S 3 degrees 00' W 1509 feet to the point of beginning, containing 53.45 acres. Surveyed by P.E. Young, Sr., Ky. Reg. L.S. No. 1422 on March 16, 1987.


