On motion of plaintiffs, by counsel, and it appearing that a petition has been filed pursuant to K.R.S. 81.050 to establish the City of Meadow Vale, and that notice of said filing having been duly advertised pursuant to said statute and by Order of this Court, and the Court being sufficiently advised,

IT IS THEREFORE ORDERED AND ADJUDGED that the following described area be, and it is hereby incorporated into a Sixth Class City known as City of Meadow Vale:

BEGINNING at an iron pipe in the Westernmost line of Hounz Lane 820 feet, more or less, from Westport Road, said point being the Northeast corner of Lot # 1, as shown on plat of Section No. 1 of Meadow Vale Section of Rolling Hills Subdivision, plat of which is recorded in Plat and Subdivision Book 20, Page 30, in the office of the Clerk of the County Court of Jefferson County, Kentucky; thence South 57 degrees 23 minutes 46 seconds West, 933.98 feet to an iron pipe; thence South 32 degrees 36 minutes 14 seconds East, 933.98 feet to a point; thence North 57 degrees 23 minutes 46 seconds East, 933.98 feet to a point; thence North 32 degrees 36 minutes 14 seconds West 933.98 feet to the point of beginning.

IT IS FURTHER ORDERED that the following named persons are hereby appointed members of the Board of Trustees of the City of Meadow Vale:

The Clerk of the Court, not later than ten (10) days after Judgment is entered herein, shall certify a copy of this Judgment to the Secretary of State of Kentucky, Frankfort, Kentucky, whose duty it shall be to properly enter and file this Judgment in the Secretary of State's office.
