AN ORDINANCE ANNEXING TO THE CITY OF
MEADOW VALE A CERTAIN TRACT OF LAND
IN THE COUNTY OF JEFFERSON, ADJACENT
TO THE PRESENT BOUNDARY LINE OF THE CITY
OF MEADOW VALE, MORE PARTICULARLY
HEREINAFTER DESCRIBED

BE IT ORDAINED BY THE CITY OF MEADOW VALE:

Section I:

Whereas, the City of Meadow Vale deemed it desirable to annex to the City of Meadow Vale a certain tract of land, being unincorporated territory within Jefferson County, and

Whereas, the City of Meadow Vale, by Ordinance No. 1, Series 1987, proposed to annex said tract of land which is described hereinafter pursuant to an agreement entered into by the City on January 19, 1987, in settlement of the remonstrance litigation in Jefferson Circuit Court, styled Roy F. McMahan, Jr., et al. v. City of Meadow Vale, et al., bearing No. 79CI-06787, and

Whereas, said Ordinance was introduced and read at two consecutive monthly meetings of the City of Meadow Vale and enacted on February 23, 1987, and

Whereas, Ordinance No. 1, Series 1987, of the City of Meadow Vale, was published in the Courier-Journal, the newspaper having the greatest circulation within Jefferson County, by legal notice on June 4, 1987, and

Whereas, no petition in opposition to the proposal to annex was filed pursuant to KRS 81A.420 within 60 days after publication of

said Ordinance and legal notice;

Therefore, the City of Meadow Vale hereby annexes the following described unincorporated territory to the City of Meadow Vale:

Beginning at the North and East right of way intersection of Westport Road and Goose Creek Road thence with the northeast right of way of Goose Creek Road N 34 degrees 16 minutes E 143.59 feet to a nail S 55 degrees 44 minutes W 20 feet to a pin N 34 degrees 16 minutes W 52.65 feet to a pipe and N 34 degrees 16 minutes W 636.79 feet to a point in said Goose Creek Road right of way corner to the South right of way of Blossom Lane thence with said right of way of Blossom Lane with an arc having the radius of 30 feet a tangent of 29.99 feet and a chord of N 10 degrees 43 minutes 12 seconds E 42.42 feet, N 55 degrees 42 minutes 24 seconds E 334.08 feet N 59 degrees 56 minutes 07 seconds E 65 feet N 68 degrees 23 minutes 35 seconds E 65.00 feet, N 77 degrees 39 minutes 51 seconds E 77.47 feet N 82 degrees 42 minutes 23 seconds E 612.15 feet N 79 degrees 54 minutes 47 seconds E 55.85 feet N 74 degrees 19 minutes 34 seconds E 55.85 feet N 68 degrees 44 minutes 00 seconds E 58.85 feet N 63 degrees 09 minutes 07 seconds E 55.85 feet N 50 degrees 01 minutes 57 seconds E 46.51 feet N 55 degrees 42 minutes 24 seconds E 81.72 feet, thence with an arc having a radius of 30 feet tangent of 29.97 feet to a chord of S 79 degrees 19 minutes 08 seconds E 42.41 feet to the right of way intersection of Blossom Lane and Hounz Lane, thence with the Southwest right of way of Hounz Lane S 34 degrees 20 minutes 33 seconds E 639.87 feet, thence with an arc having a radius of 30 feet a tangent of 32.99 feet a chord of S 13 degrees 22 minutes 44 seconds W 44.39 feet to the right of way intersection of Hounz Lane and Westport Road thence with the North right of Westport Road S 61 degrees 06 minutes 00 seconds W 974.11 feet S 62 degrees 58 minutes 56 seconds W 100.00 feet S 69 degrees 07 minutes 20 seconds W 121.78 feet S 84 degrees 25 minutes 47 seconds W 92.30 feet S 86 degrees 26 minutes 30 seconds W 94.25 feet to the point of beginning, the tract being subject to all existing easements shown upon the plats.

Section II:

The City of Meadow Vale hereby incorporates by reference all of the terms and conditions contained in Ordinance No. 1, Series 1987, of the City of Meadow Vale and the aforementioned agreement entered into by the City in the aforementioned remonstrance litigation in Jefferson Circuit Court.

Section III:


This Ordinance shall take effect upon its passage and approval and publication as required by law.
