AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF MEADOWVIEW ESTATES

AN ORDINANCE ANNEXING TERRITORY HERETOFORE PROPOSED TO BE ANNEXED TO THE CITY OF MEADOWVIEW ESTATES PURSUANT TO AN ORDINANCE HERETOFORE ENACTED AND PUBLISHED SAID TERRITORY BEING ADJACENT AND CONTIGUOUS TO THE CITY OF MEADOWVIEW ESTATES TO THE NORTH OF THE PRESENT CITY OF MEADOWVIEW ESTATES.

THE BOARD OF TRUSTEES OF THE CITY OF MEADOWVIEW ESTATES DOES
ORDAIN AS FOLLOWS:

SECTION 1. WHEREAS pursuant to Kentucky Revised Statutes 81.240, 81.100 and 81.110, authorizing cities of the sixth class to annex territory adjacent and contiguous to the boundaries of said cities, the Board of Trustees of the City of Meadowview Estates on March 22, 1954, ordained, enacted, passed and published as required by law, Ordinance No. 2 , Series 1954, of the City of Meadowview Estates, titled:

"An ordinance proposing to annex to the City of Meadowview Estates a certain tract of land in Jefferson County, Kentucky, adjacent to the North and contiguous to the present City of Meadowview Estates, more particularly hereinafter described."

and

WHEREAS no remonstrance has been filed against the annexation of said territory pursuant to said ordinance, and

WHEREAS thirty days has expired since the enactment of said ordinance, and

WHEREAS it is deemed desirable to annex said territory to the City of Meadowview Estates,

NOW THEREFORE, be it ordained that the boundaries of the City of Meadowview Estates be extended by annexing thereto the territory hereinafter described, which now is embraced in Jefferson County, Kentucky, which territory is adjacent and contiguous to the City of Meadowview Estates, to-wit:

"BEGINNING at the Northwest corner of the City of Meadowview Estates in a Northeast boundary line of the City of Louisville; thence Northwestwardly and Northeast along the boundary line of the City of Louisville to a point in the Northeast line of Breckenridge Lane; thence Southeast along the Northeast line of Breckenridge Lane to the Northeast corner of the City of Meadowview Estates; thence Westwardly along the Northerly line of Meadowview Estates to the point of beginning."

SECTION 2. There being no daily or weekly paper published in the City of Meadowview Estates it is ordered that immediately upon the effective date of this Ordinance that copies of this Ordinance be published and posted for at least ten days in four of the most public places of the City of Meadowview Estates.

SECTION 3. This Ordinance shall take effect from and after its passage and publication.
