ORDINANCE NO. 3, SERIES 1981

AN ORDINANCE ANNEXING TO THE CITY OF MIDDLETOWN A CERTAIN TRACT OF LAND LOCATED IN THE COUNTY OF JEFFERSON, STATE OF KENTUCKY, ADJOINING THE PRESENT CITY OF MIDDLETOWN, AND BEING MORE PARTICULARLY HEREINAFTER DESCRIBED.

The Trustees of the City of Middletown, Kentucky, does hereby ordain as follows:

1. The City of Middletown, Kentucky, hereby annexes that certain tract of land which is now embraced within the County of Jefferson, and which is adjacent to and contiguous with the present city boundary line in which territory is accurately defined and described as follows:

BEGINNING at the point of intersection of the southern boundary of the present City of Woodland Hills and the westerly right-of-way of Marengo Drive per Ordinance No. 14, Series 1980; thence in a northeasterly direction with the southerly boundary of the present city of Woodland Hills to its intersection with the easterly line of Crosscreek Subdivision Section 1; thence in a southeasterly direction with the easterly line of Crosscreek Subdivision Section 1, to its intersection with the northerly line of Crosscreek Subdivision Section 3-B; thence in a northeasterly direction with the northerly line of Crosscreek Subidivision Section 3-B to the northeasterly corner of Crosscreek Subidivision Section 3-B; thence in a southerly direction with the easterly line of Crosscreek Subdivision Section 3-B and a straight line of projection of the easterly line of Crosscreek Subdivision Section 3-A to its intersection with the northerly right-of-way line of Interstate 64; thence in a westerly direction with the northerly line of Interstate

64 to its intersection with a straight line projection in a southerly direction of the easterly boundary of the present City of Douglass Hills; thence in a northwesterly direction with said last mentioned line to the intersection of Ellingsworth Road and the easterly boundary of the present City of Douglass Hills; thence in a north, northeasterly direction to a point where the westerly boundary of Marengo Drive and the centerline of Pope Lick Road intersect; thence in a north, northwesterly direction with the westerly boundary of Marengo Drive to the point of beginning.

2. This Ordinance shall take effect upon its passage and approval.
