ORDINANCE NO. 7
SERIES 1981
CITY OF MIDDLETOWN

AN ORDINANCE ANNEXING TO THE CITY OF MIDDLETOWN A CERTAIN TRACT OF LAND LOCATED IN THE COUNTY OF JEFFERSON, STATE OF KENTUCKY, ADJOINING THE PRESENT CITY OF MIDDLETOWN, AND BEING MORE HEREINAFTER DESCRIBED.

THE TRUSTEES OF THE CITY OF MIDDLETOWN, KENTUCKY, does hereby ordain as follows:

1. The City of Middletown, Kentucky, hereby annexes that certain tract of land which is now embraced within the County of Jefferson, and which is adjacent to and contiguous with the present City boundary line in which territory is accurately defined and described as follows:

BEGINNING at a point in a straight line projection in a southerly direction of the easterly boundary of the present City of Douglass Hills; where such projected line intersects the south right-of-way line of Ellingsworth Road, as improved; thence in a westerly direction with the south right-of-way line of Ellingsworth Road, as improved, to a point in the south right-of-way line of Ellingsworth Road, as improved, opposite of and South 17 degrees, 50 minutes, 21 seconds East from the southwest corner of Running Creek Estates, Section 5, as recorded in Plat and Subdivision Book 31, Page 23, in the Office of the Clerk of the County Court of Jefferson County, Kentucky; thence in a northerly direction to the centerline of Ellingsworth Road; thence in a westerly direction with the centerline of Ellingsworth Road, as improved, to the point of intersection of the easterly line of the tract conveyed to William R. Griffin, et. al., by Deed as recorded in Deed Book 4622, Page 151, in the aforesaid Clerk's Office; then in a southerly direction along Griffin's East line to the northerly right-of-way line of Interstate Highway 64, also being a presently northerly boundary of the City of Jeffersontown; thence in a easterly direction with the northerly right-of-way line of Interstate Highway

64, to the point of intersection of said northerly right-of-way line and the southwestern corner of the present City of Middletown per Ordinance No. 20, Series 1980 and Ordinance No. 1, Series 1981; thence in a northerly direction to the point of beginning.

2. This Ordinance shall take effect upon its passage and approval.
