ORDINANCE NO. 9
SERIES 1983
CITY OF MIDDLETOWN

AN ORDINANCE ANNEXING TO THE CITY OF MIDDLETOWN, A CERTAIN TRACT OF LAND LOCATED IN THE COUNTY OF JEFFERSON, STATE OF KENTUCKY, ADJOINING THE PRESENT CITY OF MIDDLETOWN, AND BEING MORE PARTICULARLY DESCRIBED HEREINAFTER.

BE IT ORDAINED by the CITY OF MIDDLETOWN, KENTUCKY, by and through its CITY COMMISSIONERS, as follows:

1. The City of Middletown, Kentucky, hereby annexes that certain tract of land which is now embraced within the County of Jefferson, and which is adjacent to and contiguous with the present City property line in which territory is accurately defined and described as follows:

BEGINNING at a point, said point being the southwest corner of a tract of land conveyed to William R. Griffin, et. al., by Deed as recorded in Deed Book 4622, Page 151 in the Office of the County Court Clerk, Jefferson County, Kentucky and also in the northerly right-of-way line of Interstate Highway 64; thence westerly along the northerly right-of-way line of Interstate Highway 64 to the west line of a tract conveyed to E. F. Powers, Jr. and Evelyn B. Powers, his wife, by Deed as recorded in Deed Book 1724, Page 612 in the aforesaid Clerk's Office; thence north along the west line of Powers to the south line of a tract conveyed to Thomas Wilson by Deed as recorded in Deed Book 4695, Page 372 in the aforesaid Clerk's Office; thence west along the south line to Wilson to the east right-of-way line of Blankenbaker Lane, as relocated; thence north along the east line of Blankenbaker Lane, as relocated, to the north line of Ellingsworth Road; thence west along the north line of Ellingsworth Road extended to the west line of a tract conveyed to Carroll and Mabel Tyler by Deed as recorded in Deed Book 5293, Page 650, in the aforesaid Clerk's Office; thence along the west line of Tyler to the north line of Tyler; thence east along the north line of Tyler extended to the centerline of Blankenbaker Lane; thence north along the centerline of Blankenbaker Lane to the intersection with the south line extension of a tract of land conveyed to Victor H. and Edna Mae Schaid by Deed as recorded in Deed Book 5522, Page 186 in the aforesaid Clerk's Office; thence west, north, west and north along lines to Schaid to a point in the south line of a tract of land acquired by Lena Reichenbach per Will Book 62, Page 488 in the aforesaid Clerk's Office; thence west along the south line to Reichenbach to a point in the east line of a tract of land conveyed to Kenneth T. Burkhardt by Deed as recorded in Deed Book 4456, Page 148 in the aforesaid Clerk's Office; thence south along the east line of Burkhardt to the southeast corner of Burkhardt; thence west along the

south line to Burkhardt to the southeast corner to a tract of land conveyed to Jesse D. Brown, Jr. by Deed as recorded in Deed Book 3673, Page 541, in the aforesaid Clerk's Office; thence west along the south line of Brown, Jr. to the southeast corner of a tract conveyed to Jesse D. and Alvina Brown by Deed as recorded in Deed Book 3172, Page 325 in the aforesaid Clerk's Office; thence west along the south line to Brown to the southwest corner to Brown; thence north along the west line of Brown extended to a point in the north right-of-way line of Watterson Trail, and being also the south line of the City of Douglas Hills; thence east along the north and west right-of-way lines of Watterson Trail to the point of intersection with the north line extension of a tract of land conveyed to Joseph D. and Dorothy Warren by Deed as recorded in Deed Book 4315, Page 399 in the aforesaid Clerk's Office; thence east across Watterson Trail and along the north line of Warren to the northeast corner of Warren; thence south along the east line of Warren and continuing in a straight line to the southeast corner of a tract of land conveyed to Charles W. and Elizabeth C. Phelps by Deed as recorded in Deed Book 3378, Page 288 in the aforesaid Clerk's Office, said corner also being the corner common to Lots 136 and 137, Running Creek Estates, Section No. 3 as recorded in Plat Book 31, Page 23, in the aforesaid Clerk's Office; thence east along the south line of said Running Creek Estates, Section No. 3 to the northeast corner of a tract of land conveyed to J. D., Jr and Barbara Ann Stratton by Deed as recorded in Deed Book 4117, Page 406 in the aforesaid Clerk's Office; thence south along the east line to Stratton and west along the south to Stratton extended to the centerline of Watterson Trail; thence south along the centerline of Watterson Trail to its intersection with the westerly extension of the north line of a tract of land conveyed to Murl and Ruth M. Whitlow by Deed as recorded in Deed Book 3336, Page 311, in aforesaid Clerk's Office; thence east along the north line to Whitlow to the northeast corner to Whitlow; thence south to the southeast corner to Whitlow; thence west along the south line to Whitlow to the northeast corner of a tract of land conveyed to Thomas and Marie M. Golladay by Deed as recorded in Deed Book 1617, Page 237, in aforesaid Clerk's Office; thence south along the east line to Golladay and its extension to the centerline of Ellingsworth Road; thence east along the centerline of Ellingsworth Road to its intersection with the northerly extension of the west line of a tract of land conveyed to aforesaid William R. Griffin, et. al; thence south along said west line to Griffin to the point of beginning.

Except from the above is a tract of land located on Blankenbaker Lane and more particularly described as follows:

BEGINNING at a point said point being the intersection of the centerline of Blankenbaker Lane and the westerly extension of the south line of a tract of land conveyed to Scott Robertson and wife by Deed as recorded in Deed Book 4848, Page 181 in the aforesaid Clerk's Office; thence east along said south line to Robertson to a point in the west line of a tract of land conveyed to Louis F. and Marie Schoenbachler by Deed as recorded in Deed Book 3602, Page 146 in aforesaid Clerk's Office; thence south along the west line of Schoenbachler to the south-

east corner of a tract of land conveyed to Carl and Kathryn Gayhart by Deed as recorded in Deed Book 3870, Page 63 in the aforesaid Clerk's Office; thence along the southerly lines to Gayhart and extended to the centerline of Blankenbaker Lane; thence north along the centerline of Blankenbaker Lane to the point of beginning.

2.1 This Ordinance shall take effect upon its passage and approval and its publication according to law.
