ORDINANCE NO. 93-019

TITLE: AN ORDINANCE ANNEXING CERTAIN PROPERTY ON SPRING
STATION PIKE, MIDWAY, KENTUCKY

Whereas the City of Midway finds and declares it to be desirable for the City of Midway to annex the property described in this ordinance; and

Whereas, the City Council and the Mayor adopted and approved an Ordinance of Intent to Annex the property on March 1, 1993, (Ordinance No. 93-004) which Ordinance of Intent to Annex was duly published on March 11, 1993;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF MIDWAY, COMMONWEALTH OF KENTUCKY, AS FOLLOWS:

Section 1. The City of Midway does hereby annex into the corporate limits of the city the real property located within the following described boundaries that is not presently within the corporate limits of the City of Midway:


Beginning at the intersection of Circle Drive and Spring Station Road and running thence in a southeasterly direction with the center line of Circle Drive a distance of approximately 214 feet; thence leaving Circle Drive in a westerly direction along the fence which forms the southern boundary at an existing cemetery for a distance of approximately 172 feet; thence in northerly direction along the fence which forms the western boundary of said existing cemetery a distance of approximately 157 feet; thence in a westerly direction along the fence which forms the southern boundary of an existing sewer lift station for a distance of 26 feet; thence in a northerly direction along the fence which forms the western boundary of said sewer lift station for a distance of approximately 38.5 feet; thence continuing along the same line a distance of approximately 19 feet to the center line of

Spring Station Road; thence in a northeasterly direction along the center line of Spring Station Road a distance of approximately 198 feet to the point and place of beginning, said tract containing the existing cemetery and sewer lift station.


Section 2. This ordinance shall become effective upon passage and publication as required by law.

INTRODUCED and given a first reading at a meeting of the Midway City Council held on the 6th day of September, 1993, and fully adopted after a second reading at a meeting of said Council held on the 20th day of September, 1993.
