DE-ANNEXATION ORDINANCE

An Ordinance passed on the 20th day of January, 1983, relating to the de-annexation of certain properties on the northeast boundary of the City of Morganfield, Kentucky along one side of Beaver Dam Road.

BE IT ORDAINED by the City Council of the City of Morganfield, Kentucky, pursuant to 81A.440, as follows:

It appearing to the City Council that the property lying on the northeast boundary of the City of Morganfield, Kentucky along one side of Beaver Dam Road, should be de-annexed from the City of Morganfield, Kentucky.

NOW, THEREFORE, the City Council of the City of Morganfield, Kentucky, declares that the following described property should be de-annexed from the City of Morganfield, Kentucky:

DESCRIPTION . . .

BEGINNING at a stake in the right-of-way of Beaver Dam Road and running in an northeasterly direction the following distances: (1) N 40°54'47" E 570.06 feet; (2) N 40°14'57" E 624.84 feet; (3) N 39°53'59" E 626.60 feet; (4) S 40°23' W 569.40 feet; (5) S 40°22' W 577.64 feet; (6) S 32°21' W 145.96 feet to a stake; thence running along the right-of-way of North Avenue (7) N 74° 33' W 250.95 feet to a stake; thence running along the right-of-way of Road H-3 (8) N 16°12'31" E 716.80 feet to a stake; thence running (9) N 74°29'01" W 128.86 feet to a stake; thence running (10) N 16°01'30" E 398.91 feet to a stake; thence running (11) N 3°51'40" E 125.37 feet to a stake; thence running (12) N 86°47'51" E 478.86 feet to a stake; thence running (13) S 28°22'30" W 413.77 feet to a stake; thence running (14) S 38°13'33" W 100.71 feet to a stake; thence running (15) S 3°53'40" E 125.66 feet to a stake; thence running (16) S 14°43'44"

W 210.83 feet to a stake; thence running (17) S 10°32'28"
E 224.77 feet to a stake; thence running (18) S 44°06'
E 404.56 feet to a stake; thence running (19) S 13°42'36"
E 292.79 feet to a stake; thence running (20) S 67°54'
W 794.74 feet to a stake; thence running along the
right-of-way of Beaver Dam Road (21) N 49°05'02" W a
total of 1,225.77 feet to the point of beginning, and
containing a total of 60.396 acres, more or less.

The Council declares its intent and that it is desirable to de-annex from the City of Morganfield, Kentucky, the above described property. Pursuant to the consent of the landowners in the area proposed to be de-annexed, therefore, in accord with KRS 81A.500 and because there are no resident voters or owners of real estate in the area proposed to be de-annexed, there can be no election.

THEREFORE, BE IT ORDAINED that this Ordinance being passed and approved by the City Council of the City of Morganfield, Kentucky, on the 20th day of January, 1983, and published in the Union County Advocate on the 26th day of January, 1983, and there being no voters in the area to be de-annexed to challenge the de-annexation, upon the second reading of this Ordinance on the 27th day of January, 1983, and published in the Union County Advocate on February 2, 1983, the territory herein described is no longer a part of the City of Morganfield, Kentucky.

PASSED AND APPROVED on a second reading at a special meeting of the City Council of the City of Morganfield, Kentucky, held on the 27th day of January, 1983.

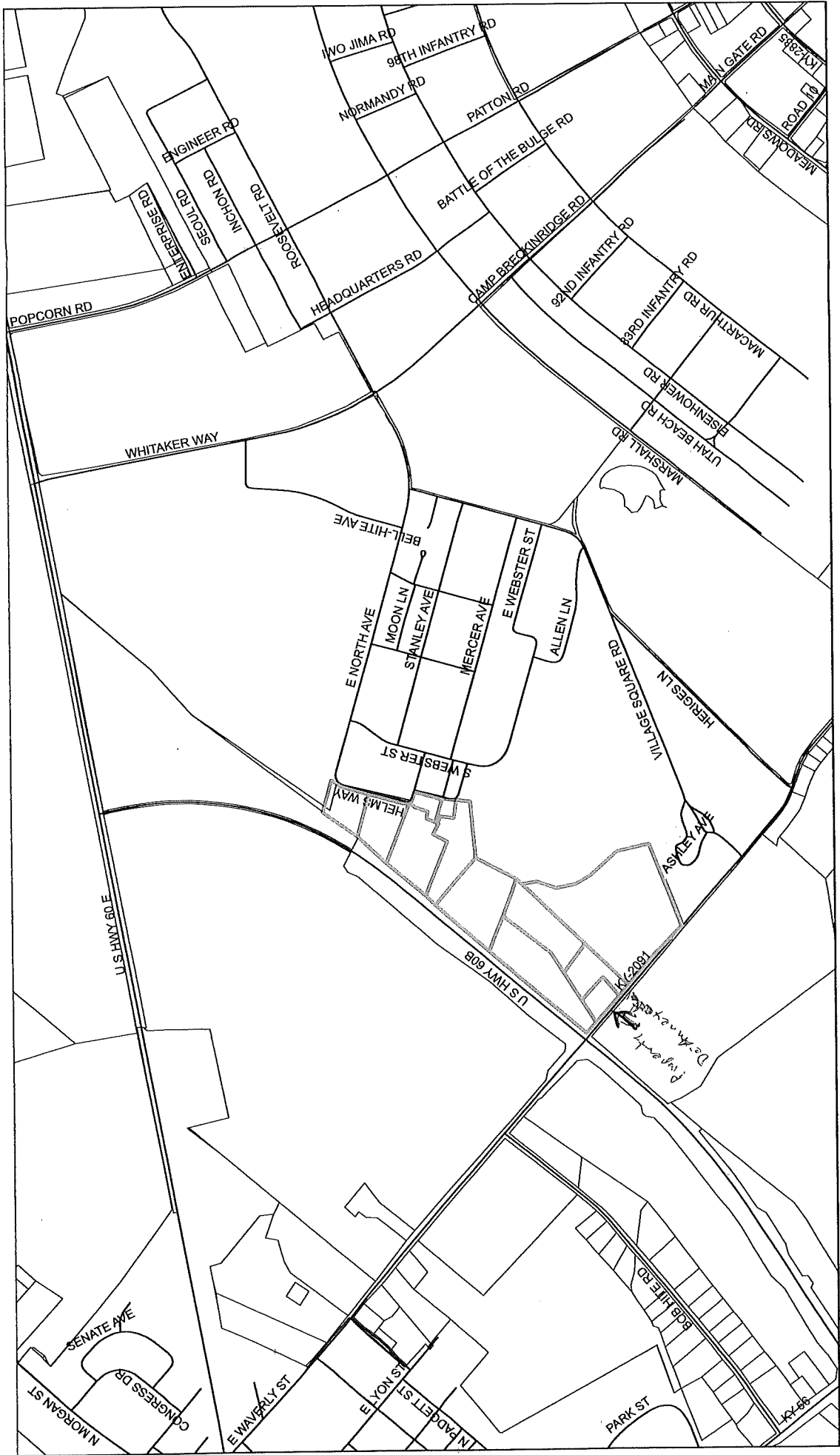
