


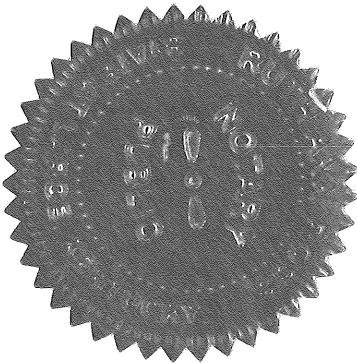

AN ORDINANCE ANNEXING 18.3742 ACRES OF LAND ADJOINING THE PRESENT CITY LIMITS ON THE NORTH, ALONG US 62.

SUMMARY

This Ordinance annexes 18.3742 acres of land adjoining the present city limits on the north, along US 62. The annexation includes property owned by Robertson County Board of Education.

PREAMBLE

WHEREAS, the 18.3742 acres of land, more or less, adjoining the present city limits on the north, along US 62, hereby annexed, is urban in nature; and

WHEREAS, the city finds it necessary and beneficial that for in order to provide full police protection, city utilities and other municipal services this unincorporated territory must be annexed into the City; and

WHEREAS, said 18.3742 acres, more or less, as hereinafter described, is adjacent and contiguous to the existing territorial limits of the City; and

WHEREAS, no part of the territory hereby proposed to be annexed is included within the boundary of another incorporated city.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF MT. OLIVET, KENTUCKY, as follows:

- (1) It is found, determined, and declared that the recitals in the Preamble to this Ordinance, which are hereby incorporated in the section (1) by reference, are true and correct.
- (2) It is hereby declared to be desirable for the City of Mt. Olivet to annex the unincorporated territory hereinafter described.
- (3) The following described territory located in Robertson County, Kentucky, is hereby annexed to the City of Mt. Olivet, to-wit:

PARCEL I, TRACT I & II, D.E. 32, PG. 476

Beginning at a point in the right of way line of US Highway 62, having a northing of 376,944.47 and an easting of 1,702,758.93 in US State Plane 1983 HPGN coordinates of the Kentucky North 1601 Zone, measured in US Survey Feet being a corner to Mrs. Myrtle Clark, thence proceeding N34° 01' E. 153.120 feet. Then proceeding the following bearings and distances:

- (5) The City Clerk is hereby directed, within sixty days after final adoption of this Ordinance, to cause an accurate map clearly delineating the above-described territory, showing the above notes and bounds description, together with a copy of this Ordinance duly certified, to be recorded in the office of the Robertson County Clerk and files in the offices of the Kentucky Secretary of State and Department for Local Government in compliance with KRS 81A.470(1) and 81A.475.
- (6) The City Clerk is hereby directed, within sixty days after final adoption of the Ordinance, to provide to the Robertson County Clerk a list of names and addresses of those property

owners and/or registered voters who reside in the annexed territory, with the map required in section (5) above.
