ORDINANCE NO. 97- 2

AN ORDINANCE CONFIRMING ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF MT. WASHINGTON, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:

SECTION I: The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, as such territory shall become a part of the Commonwealth of Kentucky; and further, such territory annexed is described as follows:

Beginning at a point at the northeast corner of Marilyn Heights Subdivision as recorded in Plat Cabinet _____, Page _____, in the office of the Clerk of Bullitt County, Kentucky; thence with the north line of Marilyn Heights aforesaid North 78 Degrees, 36 Minutes, 47 Seconds West, 1130.17 feet to a point, said point being the Northwest corner of Marilyn Heights aforesaid; thence with the west line of Marilyn Heights aforesaid, South 11 Degrees, 23 Minutes, 13 Seconds West, 380.00 feet to a point; thence continuing with the west line of Marilyn Heights aforesaid, South 9 Degrees, 45 Minutes, 52 Seconds West 50.02 feet to a point; thence continuing with the West line of Marilyn Heights aforesaid, South 11 Degrees, 23 Minutes, 12 Seconds West, 110.18 feet to a point in the north line of Colonial Aire, Section One (1) plat of which is recorded in Plat Book 6, Page 96 (Plat Cabinet 1, Slide 392) in the office of the Clerk of Bullitt County; thence with the North line of Colonial Aire, Section One (1), North 78 Degrees, 37 Minutes, 35 Seconds West, 419.26 feet to a point at the northwest corner of said Colonial Aire Section One (1); thence North 78 Degrees, 35 Minutes, 27 Seconds West, 717.29 feet to a point; thence North 11 Degrees, 20 Minutes, 11 Seconds East, 250.31 feet to a point; thence North 63 Degrees, 25 Minutes, 11 Seconds East 246.90 feet to a point; thence South 89 Degrees, 51 Minutes, 45 Seconds East, 257.84 feet to a point; thence North 89 Degrees, 03 Minutes, 25 Seconds East, 100.00 feet to a point; thence North 00 Degrees, 56 Minutes 35 Seconds West, 200.00 feet to a point in the South right of way of Highway 44; thence with the South right of way of Highway 44, the following calls and distances: North 89 Degrees, 04 Minutes, 22 Seconds East, 655.98 feet; thence South 89 Degrees, 27 Minutes, 39 Seconds East, 152.02 feet; thence South 86 Degrees, 31 Minutes, 40 Seconds East, 152.02 feet; thence


South 83 Degrees, 29 Minutes, 05 Seconds East, 151.98 feet; thence South 82 Degrees, 07 Minutes, 42 Seconds East, 588.01 feet to a point; thence leaving said Highway 44, South 13 Degrees, 48 Minutes, 50 Seconds West, 151.07 feet to a point; thence South 82 Degrees, 40 Minutes, 01 Seconds East, 100.03 feet to a point; thence South 13 Degrees, 48 Minutes, 50 Seconds West, 223.98 feet to the point of beginning and containing 23.5 acres more or less.

SECTION II: The City Clerk is hereby directed to publish this Ordinance in accordance with the Kentucky Revised Statutes.
