AN ORDINANCE CONFIRMING ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF MT. WASHINGTON, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:


**SECTION I:** The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, as such territory shall become a part of the Commonwealth of Kentucky; and further, such territory annexed is described as follows:

Greenbriar Woods, Section 2 Revised and Greenbriar Road Right-of-Way

Beginning at a point in the intersection of the north right-of-way line of KY 44 and the west right-of-way of Greenbriar Road; thence with the west right-of-way line of Greenbriar Road approximately N 33 15' E 1565 feet, more or less, to an iron pin, the southeast corner of Greenbriar Woods Subdivision, Section 2 Revised; thence N 55 29' 07" W 544.64 feet to a point; thence N 55 13' 43" W 264.72 feet to a point; thence S 35 46' 23" W 277.66 feet to a point; thence N 55 30' 37" W 806.82 feet to a point; thence N 33 30' 10" E 1096.00 feet to a point; thence N 33 44' 20" E 777.84 feet to a point; thence S 57 14' 07" E 582.42 feet to a point; thence S 56 45' E 785.48 feet to a point; thence S 34 15' W 152.50 feet to a point; thence S 56 00' E 267.58 feet to a point in the west right-of-way of Greenbriar Road; thence with the west right-of-way of Greenbriar Road S 33 52' 43" W 1012.91 feet to a point; thence N 78 08' 22" W 36.96 feet to a point in the east right-of-way of Greenbriar Road; thence with the east right-of-way of Greenbriar Road S 33 30' W approximately 2041 feet to a point in the North right-of-way of KY 44; thence with the north right-of-way of KY 44 in a westerly direction 33 feet, more or less, to the point of beginning, containing 66.4 acres, more or less.

**SECTION II:** The City Clerk is hereby directed to publish this Ordinance in accordance with the Kentucky Revised Statutes.


