ORDINANCE NO. 97- 17

AN ORDINANCE CONFIRMING ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF MT. WASHINGTON, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:

SECTION I: The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, as such territory shall become a part of the Commonwealth of Kentucky; and further, such territory annexed is described as follows:

TRACT 1, BARBARA SUE LANE RIGHT-OF-WAY

Beginning at a point in the west right-of-way line of Armstrong Lane; thence S 63°13'08" E 15 feet, more or less, to point in the centerline of Armstrong Lane; thence S 63°13'08" E 1214.06 feet to a point; thence continuing with the north right-of-way of Barbara Sue Lane S 63°13'08" E 197.25 feet to a point; thence S 63°09'12" E 1233.55 feet to a point, said point in the current municipal boundary of the City of Mt. Washington; thence S 22°18'45" W 50.156 feet to a point in the south right-of-way of Barbara Sue Lane; thence with the south right-of-way of Barbara Sue Lane N 63°09'12" W 1237.49 feet to a point; thence N 63°13'08" W 1410.59 feet to a point in the centerline of Armstrong Lane; thence N 63°13'08" W 15 feet, more or less, to a point in the west right-of-way of Armstrong Lane; containing 3.06 acres, more or less.


TRACT 2, AUTUMN GLEN DEVELOPMENT

Beginning at a point in the west right-of-way of Armstrong Lane, said point being the southeast corner of the Hall Living Trust property; thence with the west right-of-way of Armstrong Lane S 26°30'18" W 768.49 feet to a point; thence S 25°23'24" W 425.42 feet to a point; thence S 25°56'15" W 400.00 feet to a point; thence N 64°03'45" W 1500.00 feet to a point; thence N 17°19'37" E 1304.10 to a point, said point being the southeast corner of the Norman Gentry property and the southwest corner of the Kelsey Webber property; thence with the south line of the Kelsey Webber property, S 84°29'47" E 725.74 feet to a point; thence S 66°55'58" E 1020.00 feet to the point of beginning, containing 55.74 acres, more or less.

SECTION II: The City Clerk is hereby directed to publish this Ordinance in accordance with the Kentucky Revised Statutes.


