ORDINANCE NO. 2001- 22

AN ORDINANCE CONFIRMING ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF MOUNT WASHINGTON, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:

SECTION I: The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, and such territory shall become a part of the City of Mt. Washington; and further, such territory annexed is described as follows:

BEGINNING at an iron pin in the South right of way line of Kentucky Highway 44 corner to Brothers and Whitney and Thompson; thence leaving said right of way South 6 degrees 32 minutes 49 seconds East 592.87 feet; thence South 38 degrees 50 minutes 45 seconds West 59.35 feet; thence South 77 degrees 55 minutes 47 seconds West 53.88 feet; thence North 80 degrees 13 minutes 32 seconds West 45.73 feet; thence North 72 degrees 10 minutes 16 seconds West 98.22 feet; thence North 47 degrees 05 minutes 34 seconds West 60.29 feet; thence South 85 degrees 44 minutes 53 seconds West 22.03 feet; thence North 49 degrees 14 minutes 03 seconds West 47.16 feet; thence North 83 degrees 58 minutes 06 seconds West 71.30 feet; thence North 21 degrees 00 minutes 31 seconds East 312.50 feet to an iron pipe; thence North 07 degrees 01 minutes 38 seconds West 192.75 feet to the South right of way line of Kentucky Highway 44; thence North 78 degrees 40 minutes 10 seconds East 150 feet to an iron pipe. Thence North 79 degrees 27 minutes 16 seconds East 100 feet to an iron pipe and the point of beginning and containing four acres as per survey of John A. St. Clair dated May 31, 1990, and attached to Deed of record in Deed Book 377, Page 171, in


the Office of the Clerk of the County Court of Bullitt County, Kentucky.

BEING the same property conveyed to TERRY L. THOMPSON and SHERRI THOMPSON, his wife, by Deed dated August 23, 1993, of record in Deed Book 377, Page 171, in the Office of the Clerk of the County Court of Bullitt County, Kentucky.

SECTION II: The City clerk is hereby directed to publish this ordinance in accordance with the Kentucky Revised Statutes.


