ORDINANCE NO. 2002-15

AN ORDINANCE CONFIRMING ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF MOUNT WASHINGTON, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:

SECTION I: The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, and such territory shall become a part of the City of Mt. Washington; and further, such territory annexed is described as follows:

Beginning at an iron pin in the right of way known as KSR 44 corner to Burkhead, and adjacent to the existing limits of the City of Mt. Washington, thence is a line S. 16° 30' 00" E. 389.0 feet to the corner of Clark and Roggenkamp, thence, S. 66° 26' 47" W. 637.75 feet to an iron pin at corner post, thence N 16° 30' 00" W. 397.50 feet to KSR 44 thence N. 64° 19' 37" E. 166.17 feet to an iron pin and continuing with KSR 44 462.12 feet to the point of beginning containing 5.7363 acres more or less as shown by survey of John G. St. Clair dated May 2, 1987, plat attached hereto.

SECTION II: The City clerk is hereby directed to publish this ordinance in accordance with the Kentucky Revised Statutes.


