ORDINANCE NO. 92-14

AN ORDINANCE CONFIRMING ANNEXATION OF UNINCORPORATED TERRITORY ADJOINING THE CITY OF MT. WASHINGTON, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:

SECTION I: The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, as such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory to be annexed is described as follows:

Beginning at a spike in the North right of way of Kentucky Highway #44, corner to Bland Porter; thence with line of Bland Porter, North 17°55' East, 303.2 feet to a spike in the center line of Fisher Lane; thence running with the center line of Fisher Lane, North 55°17' West, 1,091.5 feet to a spike in the center line of Fisher Lane, corner to Jean Hall; thence with line of Jean Hall, South 36°58' West, 502 feet to a stake; thence South 6°30' East, 475.4 feet to a post in the north right of way of Kentucky Highway #44; thence running with Kentucky Highway #44, South 88°00' East, 1,055.3 feet to the point of beginning, containing 16.17 acres as shown by survey of Curtis Ochs, Jr.

Being the same property conveyed to Bobby J. Hall by Alon Hall by deed dated March 7, 1984, recorded in Deed Book 264, Page 36, in the Office of the Clerk of the Bullitt County Court.

SECTION II: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION III: This Ordinance shall be published according to law.
