AN ORDINANCE CONFIRMING ANNEXATION OF
UNINCORPORATED TERRITORY ADJOINING THE CITY OF MT.
WASHINGTON, BULLITT COUNTY, KENTUCKY

BE IT ORDAINED by the City Council of the City of Mt. Washington, Bullitt County, Kentucky, as follows:

SECTION I: The City Council of the City of Mt. Washington, Bullitt County, Kentucky, does hereby ordain that it confirms the annexation of certain unincorporated territory to the City of Mt. Washington, Bullitt County, Kentucky, as such territory shall become a part of the Commonwealth of Kentucky; and further, such territory annexed is described as follows:

BEING a tract of land in Bullitt County, Kentucky, on the North Side of Kentucky Highway 44 and West Side of Kennedy Drive and East Side of Lloyd Lane being more particularly described as follows:

BEGINNING at an iron pin in the Northeast corner of the intersection between Kentucky Highway 44 and Lloyd Lane; thence with the East right-of-way of Lloyd Lane N 09° 40' 00" W 240.49' to a pin; thence N 76° 40' 46" E 544.67 to a pin; thence S 13° 19' 17" E with the west right-of-way of Kennedy Drive 240.00'; thence S 76° 40' 46" W with the north right-of-way of Kentucky Highway 44 610.00' to the point of beginning, containing 3.32 acres, more or less.

SECTION II: The City clerk is hereby directed to publish this Ordinance in accordance with the Kentucky Revised Statutes.
