ORDINANCE 2022-1818

AN ORDINANCE OF THE CITY OF MURRAY, KENTUCKY ANNEXING AN 8.241 ACRE TRACT OF LAND, SPECIFICALLY BEING PASCHALL TRUCK LINES LOT 3 LOCATED AT 3200 US HIGHWAY 641, NORTH, MURRAY, KY, OWNED BY PASCHALL TRUCK LINES, INC. AND CONTIGUOUS TO THE PRESENT CITY LIMITS.

WHEREAS, the owner of record of the land to be annexed has given prior written consent as shown by their consent dated December 3, 2021 (a copy is attached hereto and incorporated by reference as if fully stated herein and marked EXHIBIT "A"). Therefore, pursuant to KRS 81A.412., there is no requirement for a notification ordinance (KRS 81A.420)(1) or notice requirement (KRS 81A.425), or waiting period of 60 days (KRS 81A420(2)) prior to enacting a final ordinance annexing the subject area: and;

WHEREAS, the City of Murray determined that the real property more particularly described on Exhibit "B" (legal description) and Exhibit "C" (plat) shall be annexed into the city limits;

WHEREAS, this ordinance is authorized by KAR 81A.412.

NOW THEREFORE PURSUANT TO THE AUTHORITY IN CHAPTER 81A OF THE KENTUCKY REVISED STATUTES AND OTHER APPLICABLE LAW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MURRAY AS FOLLOWS, TO-WIT:

- 1. The City of Murray has declared the following The property, by reason of present use and potential, to be urban in character and/or suitable for development for urban purposes without reasonable delay, more particularly described on Exhibit "B" (legal description) and Exhibit "C" (plat) respectively attached hereto and incorporated by reference as if fully stated herein is hereby annexed into the city limits of the City of Murray.
- 2. Upon final approval of this annexation, a zoning map reflecting the zoning designation of this property shall be attached and incorporated by reference as if fully stated herein.
- 3. This ordinance shall become effective on the date of its passage and publication in the Murray Ledger & Times as required by KRS Chapter 424.

Nothing in this Ordinance shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost impaired or affected by this Ordinance.
