ORDINANCE 146-2024

AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF 22.29 ACRES OF REAL PROPERTY LOCATED AT 1075 ASHGROVE ROAD, BETWEEN BETHEL HARVEST DRIVE AND LEE BURTON LANE (PVA PARCEL NO. 067-00-00-019.02) INTO THE CITY OF NICHOLASVILLE, KENTUCKY.

- **WHEREAS**, inasmuch as KRS 81A.412 provides for the annexation of unincorporated land by cities upon the prior written consent and request of the owners of record of the land to be annexed; and,
- WHEREAS, All Nations United Methodist Church Inc. (formerly known as Lexington United Methodist Church, Inc., formerly known as St. Andrews United Methodist Church with Brick by Brick Ministries, Inc.), a Kentucky non-profit corporation, has requested and has given its consent in writing to the annexation of a portion of its real property located at Ashgrove Road, Nicholasville, Kentucky consisting of 22.29 acres (a portion of PVA Parcel # 067-00-00-019.02); and,
- WHEREAS, the City of Nicholasville, by and through its Board of Commissioners, has determined that the land requested to be annexed by All Nations United Methodist Church, meets the requirements of KRS 81A.410; and,
- WHEREAS, the City of Nicholasville, by and through its Board of Commissioners, deems it desirable to annex the above referenced real property of All Nations United Methodist Church, which is more particularly described below.

BE IT ORDAINED BY THE CITY OF NICHOLASVILLE the City of Nicholasville, by and through its Board of Commissioners, does hereby adopt this Ordinance annexing the following described real property, to-wit:

Upon the enactment of this Ordinance, and pursuant to the provisions of KRS 81A.412, the above described real property shall henceforth become and be a part of the City of Nicholasville.

Prior to the completion of annexation under KRS 81A.412, the Board of Commissioners of the City of Nicholasville has elected to establish the zoning for the newly annexed and above described real property pursuant to KRS 100.209 to be included in the R-1E Single Family Residential zoning district.

Appended hereto and included as a part of this Ordinance is a map showing the zoning which will be effective for the above described annexed land.

This ordinance will take effect upon adoption, execution and publication.

Re: Property Annexation Notice

Dear Judge West and Magistrates:

The Kentucky legislature recently passed legislation that became law without the Governor's signature which affects annexation of property by cities. Senate Bill 141, Section 3, also cited as Kentucky Acts - Chapter 128, Section 3, imposes a moratorium on annexations with certain exceptions.

All Nations United Methodist Church Inc. (formerly known as Lexington United Methodist Church Inc., formerly known as St. Andrews United Methodist Church with Brick by Brick Ministries, Inc.), a Kentucky non-profit corporation, owns 22.29 acres of property commonly known as 1075 Ashgrove Road. The landowner has requested annexation into the City of Nicholasville. This property is on Ashgrove Road between Bethel Harvest Drive and Lee Burton Lane and more specifically is situated in the north central area of Jessamine County, Kentucky, bounded on the West by Fairview Farm Subdivisions, to the South by Sibu Saha, on the East by the Methodist Home of Kentucky, and to the North by All Nations United Methodist Church Inc.

One of the exceptions to the law is the City may proceed with and annex property contiguous to its boundary as long as it provides 45 days' notice to the Jessamine County Fiscal Court of its intended action prior to enacting the annexation ordinance. This letter is intended as compliance with the Act on behalf of the Nicholasville City Commission and the City of Nicholasville.


