If no Petition has been filed with the Mayor within 60 days after the date of enactment of this Ordinance, wherein 50% of the resident voters or owners of real estate within the limits of the property described in Exhibit "A", then a Final Ordinance will be presented to the legislative body whereupon the enactment of

annexation shall be final.

Two (2) boundaries of land situated south of and adjacent and contiguous to the Corporate Limits of the City of Nicholas-ville and being more particularly described as follows, TO WIT:

Beginning at the common corner of Sargent & Greenleaf, Inc. (DB 173, page 233) and Reynolds/McCurtry on the line of Moynahan/ Moynahan (DB 120, page 239, Parcel 6), said point being the current (1986) southeasterly corner of the Corporate Limits of the City of Nicholasville, thence in a generally southern direction with the aforementioned Parcel 6 of Moynahan/Moynahan to a common corner of Reynolds/McMurtry and Moynahan/Moynahan on the northerly boundary of Betty Simpson Shouse (DB 131, page 634 & DB 131, page 641 and DB 158, page 232), thence with the northerly boundary of said Shouse in a generally westward direction to a common corner of Reynolds/McMurtry and Virginia T.
