

ORDINANCE - 572-2005

AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF
THE HEREINAFTER DESCRIBED PARCEL OF LAND INTO THE CITY
OF NICHOLASVILLE, KENTUCKY

WHEREAS, on AUGUST 4, 2005 (541-2005) the City of Nicholasville
by and through its Board of Commissioners passed an Ordinance of
Intent to annex all of the property known and described herein as
Exhibit "A";

WHEREAS, no protest or petition has been filed with the Mayor
of the City of Nicholasville within the sixty (60) days after the
date of the enactment of the Ordinance of Intent;

A TRACT OF LAND SITUATED TO THE EAST SIDE OF U.S. 27 (NICHOLASVILLE ROAD) IN JESSAMINE COUNTY, KENTUCKY AND MORE FULLY DESCRIBED AND BOUNDED AS FOLLOWS:

Beginning at a point in the eastern right-of-way line of U.S 27; thence with the property line S 69-40-00 E, 1630.53 feet; thence with the property line S 19-13-18 W, 215.22 feet; thence with the property line N 71-45-00 W, 928.50 feet; thence with the property line N 74-20-00 W, 309.00 feet; thence with the property line N 79-15-00 W, 405.27 feet; thence with the property line N 20-27-47 E, 341.54 feet to the point of beginning and containing 9.60 acres more or less.
