RESOLUTION 012909C

A RESOLUTION ADOPTING A LEGAL DESCRIPTION OF TERRITORY PREVIOUSLY ANNEXED BY ORDINANCE

WHEREAS, the City of Nicholasville has enacted previous ordinances annexing property into the corporate limits of the City of Nicholasville; and

WHEREAS, the City of Nicholasville wishes to provide an accurate, identifiable legal description reflecting bearings and coordinates based upon the state plane coordinate system, including relevant GPS and GIS data, same having been certified by a professional land surveyor for each prior annexation; and

WHEREAS, the City of Nicholasville wishes to comply with requirements of Amended KRS 81A.470 effective July 13, 2004, and

WHEREAS, the City of Nicholasville does not intend to amend or replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously annexed and adopt an accurate legal description of territory previously annexed.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NICHOLASVILLE, KENTUCKY AS FOLLOWS:

That the Board of Commission of the City of Nicholasville hereby adopts the following legal description and a plat attached hereto as prepared by Licensed Professional Land Surveyor No. 1218 by new survey as an accurate depiction of the property previously annexed into the corporate city limits of the City of Nicholasville by Ordinance 1-D-83 dated January 25, 1983, a copy of which is attached hereto as Exhibit "A", and hereby adopts said new legal description and plat as the official legal description and plat to be adopted by the City for all purposes when referencing prior annexation.

This new legal description as prepared by John G. Horne a Licensed Professional Land Surveyor No. 1218 as follows:

ORDINANCE 1-D-83

AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF THE HEREINAFTER DESCRIBED PARCEL OF LAND INTO THE CITY OF NICHOLASVILLE, KENTUCKY

NICHOLASVILLE ANNEXATION AREA I

Beginning at a point in the north right-of-way of Kentucky Highway 29, said point being the southwest corner of the same property conveyed to Jessamine County Board of Education by S.A.Camp Ginning Company and recorded in Deed Book 101, Page 511 of the Office of the Clerk of Jessamine County; thence South 23°48' West a distance of 30 feet to the point of centerline intersection of KY. 29 with Old KY.29 (hereinafter called Old Wilmore Road); thence with the centerline of Old Wilmore Road the following four (4) calls: South 58°30' East a distance of 760 feet; South 62°45' East a distance of 110 feet; South 78°30' East a distance of 105 feet; South 80°30' East a distance of 355 feet to a point in the north right-of-way of the Southern Railroad; thence easterly with the north right-ofway of the Railroad a distance of 1110 feet ± to a point in the centerline of KY. 29; thence North 42°46' East a distance of 40 feet to a point in the north right-of-way of KY. 29; thence with the right-of-way North 47°14' West a distance of 26.4 feet; thence with the right-of-way and a curve to the left a chord bearing North 50°33' West a distance of 78.24 feet; thence with the rightof-way South 36°09' West a distance of 10 feet; thence with the right-of-way 30 feet north of and parallel with KY. 29; in a westerly direction a distance of 2234 feet ± to the point of beginning and containing 13.6 acres more or less.
