

JUDGMENT

On motion of the Petitioners herein, and upon the Court's finding that proper publication of this action has been made in accordance with KRS 81.050 and that no defense to this action has been interposed, and the Court being otherwise sufficiently advised, IT IS HEREBY ORDERED AND ADJUDGED as follows:

(1) The following described area, situated in Jefferson County, Kentucky, is hereby incorporated as a

city pursuant to the authority of Sections 81.040 - 81.060
of the Kentucky Revised Statutes:

BEGINNING at an iron pipe marking the intersection of the Northwestwardly line of U.S. Highway #42 with the Southwestwardly line of Glenview Avenue, said pipe also being a corner of Lot 1 as shown on plat of Northfields Subdivision Section 1, plat of which is of record in Plat and Subdivision Book 12 Page 59 in the office of the Clerk of the County Court of Jefferson County, Kentucky; thence Southwestwardly and at right angles to Glenview Avenue 2600 feet; thence Northwestwardly at right angles to said last mentioned line 2600 feet; thence Northeastwardly at right angles to said last mentioned line 2600 feet to the Southwestwardly line of Glenview Avenue; thence Southeastwardly with the Southwestwardly line of Glenview Avenue 2600 feet to the point of beginning.

(2) Said incorporated city shall be designated as the City of Northfield;

(3) The Jefferson Circuit Court Clerk is hereby directed to certify and deliver to the Secretary of State, Frankfort, Kentucky, a copy of this Judgment by not later than ten (10) days following the entry hereof;

(4) CLIFFORD L. SAWYER, WILLIAM G. SPIEGELHALTER, HAROLD HAMMON, IRWIN WATERMAN and E. J. LAMY are hereby appointed Trustees of the City of Northfield to serve until their successors may be elected and qualified;

(5) FRANK J. DOUGHERTY, JR., JACK KAISER and EARL MAGESTER are hereby appointed Police Judge, Marshall

and Assessor, respectively, of the City of Northfield to
serve until their successors may be elected and qualified.
