to the Court that a Petition has been filed to establish the City  
of Norwood pursuant to KRS 81.050; that notice of said filing having  
been duly advertised pursuant to KRS Chapter 424; that all the statu-  
tory requirements for incorporation by said City having been met;  
and the Court being sufficiently advised,

IT IS HEREBY ORDERED AND ADJUDGED that the following described  
area be and it is hereby incorporated into a Sixth Class City known  
as the City of Norwood, situated in Jefferson County, Kentucky, to wit:

BEGINNING at the corner of easterly line  
Boone Highway and the original north line  
of Shelbyville Road as shown on the plat of  
Norwood Place, revised, a plat of which is  
recorded in Plat and Subdivision Book 4,  
Page 76, in the office of the Clerk of County  
Court of Jefferson County, Kentucky, thence  
S. 1°41'W. 100.0 feet to the original South  
R/W of Shelbyville Road: Thence with said line  
S. 87°19'E. 1480.0 feet. Thence N. 1°41'E.  
1480.0 feet, thence N. 87°19'W. 1103.12 feet  
to South Line of Woodside Ave. now known as  
La Grange Road. Thence with said line S.

52.08'W. 421.61 feet, thence south 37 degrees 52" east, 120 feet to a pipe; north 52 degrees 8' east, 110 feet to a pipe; south 44 degrees 55' east, 128.52 feet, to a point in the west line of Norwood Drive, thence along Norwood Drive, also of record in the above mentioned Plat and Subdivision Book and Page, south 26 degrees 19' west, 75 feet to a point; south 17 degrees 30' west, 75 feet to a pipe; south 3 degrees 37' west, 73.33 feet to a pipe; south 3 degrees 58.25" west, 52.90 feet to a point; south 16 degrees 5'8" east, 97.95 feet to a point; south 56 degrees 10'39" west, 197.95 feet to a point; south 39 degrees 18'33" west, 139.8 feet to a point on the east line of Boone Highway; thence with the east line of Boone Highway S.5°12' W; 160.0 feet, S. 15°16'W. 92.59 feet, and S.4°46'W 170.11 feet to the Beginning.
