ORDINANCE 32-2017

ALISON LUNDERGAN GRIMES AN ORDINANCE ANNEXING TO THE CITY OF SECRETARY OF STATE MONWEALTH OF KENTL UNINCORPORATED **OWENSBORO** CERTAIN By Kandie DAVIESS TERRITORY IN THE COUNTY OF ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT THE BLOCK OF 2200-2300 SCHERM ROAD, RIGHT-OF-WAY, CONTAINING 2.13 ACRES, MORE OR LESS.

WHEREAS, the Board of Commissioners for the City of Owensboro, Kentucky, makes the following findings of fact:

(1) The Board of Commissioners has determined that the property described hereinbelow is adjacent or contiguous to the city's boundaries.

(2) That it is deemed desirable and it is hereby proposed to annex to the City of Owensboro by extending the boundary line of the city so as to include within the same, that certain territory which is now embraced within the County of Daviess adjoining the present boundary line of the City of Owensboro, as more particularly described herein. The Board further finds that no part of the area to be annexed is presently within the boundary of any other incorporated city.

(3) That the fee simple owners of record of the territory to be annexed, have previously consented in writing to the annexation proposed, and have otherwise waived all rights under KRS 81A.412, 81A.420 and 81A.425, which consent and waiver is on file with the office of the City Engineer. There is no annexation incentive agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

Section 1. The findings of fact recited in the preamble hereinabove are hereby adopted, affirmed and incorporated by reference as if fully set forth herein.

Section 2. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

A section of right of way located on the west side of Owensboro, Daviess County, Kentucky at the intersection of Scherm Road and Barron Drive more particularly described as follows:

Beginning at a point at the intersection of the east right of way line of Barron Drive and the north right of way line of Scherm Road, said point being in the current city limit line; thence following the north right of way line of Scherm Road and the current city limit line as follows: N 88°18'54" E, 275.86 feet to a point; thence S 48°13'06" E, 73.04 feet to a point; thence S 85°55'06" E, 230.35 feet to a point; thence N 84°07'53" E, 698.75 feet to a point in the north right of way line of Scherm Road; thence crossing the right of way of Scherm Road and following the current city limit line S 17°17'26" W, 72.07 feet to a point in the south right of way line of Scherm Road, said point being in the current city limit line; thence following the south right of way line of Scherm Road and the current city limit line as follows: S 84°36'39" W, 53.23 feet to a point; thence S 84°04'55" W, 164.88 feet to a point; thence S 84°40'04" W, 75.33 feet to a point; thence S 87°47'51" W, 52.04 feet to a point; thence S 85°54'52" W, 210.54 feet to a point; thence S 84°32'10" W, 115.52 feet to a point; thence N 88°28'21" W, 75.03 feet to a point; thence N 83°23'12" W, 69.46 feet to a point; thence N 82°06'30" W, 101.97 feet to a point; thence S 47°07'16" W, 57.31 feet to a point; thence S 41°59'14" W, 99.95 feet to a point in the east right of way line of Barron Drive, said point being in the current city limit line; thence following the new city limit line N 46°25'02" W, 290.99 feet to the point of beginning containing 2.123 Acres as shown on an annexation exhibit prepared by the City of Owensboro.

Section 3. That the territory annexed herein is zoned both Urban Agriculture A-U

and Single Family Residential R-1C, as illustrated by the zoning maps attached hereto

and incorporated by reference herein.

Section 4. Any dedicated streets, alleys, or easements constituting any portion of

the property to be annexed are hereby accepted by the City of Owensboro pursuant to

KRS 82.400.
