ORDINANCE NO. 11-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED ON SALEM DRIVE (GODFATHER'S PIZZA RESTAURANT), CONTAINING 0.80 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>111-80</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>December 5</u>, 19<u>80</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the east margin of Salem Drive, said point being 166.50 feet east of the east margin of U.S. 431 and corner to Family Sizzler Restaurant property, said point also being in the present city limits line; thence with the east margin of Salem Drive north 51° 30' east 33.62 feet to a point; thence north 39° 51' east 28.33 feet to a point; thence south 79° 38' east 217.62 feet to a point; thence south 10° 28' west 152.75 feet to a point; thence north 79° 32' west 218.44 feet to a point; thence north 10° 23' east 102.36 feet to a point; thence north 79° 38' west 35.00 feet to the point of beginning and containing 0.80 acres, more or less.
