## ORDINANCE NO. 20-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 930 DIXIANA DRIVE, CONTAINING 0.25 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>3-81</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>January 16</u>, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the south margin of Dixiana Drive, said point also being in the east margin of Meadowland Drive, said point also being in the present city limits line; thence in an eastwardly direction 143 feet to a point; thence in a southerly direction 135 feet to a point; thence in a westerly direction 19.88 feet to a point, said point also being in the present city limits line; thence with the present city limits line in a northwestwardly direction 182.6 feet to the point of beginning and containing 0.25 acres, more or less.
