

ORDINANCE NO. 45-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED ON HACIENDA LANE (FORMERLY BECK DRIVE) OFF THE OLD HARTFORD ROAD NEAR THE BY-PASS, CONTAINING 1.01 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 15-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on March 13, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the west margin of Old Hartford Road, Ky. 298, as it intersects the south margin of Hacienda Lane; said point being in the existing city limits line; thence with the south margin of Hacienda Lane; and the present city limit; south $51^{\circ} 29'$ west, 214 feet to a point; thence leaving the south margin of Hacienda Lane, south $33^{\circ} 45'$ east, 249 feet to a point in the north line of Carriage Hills Subdivision; thence with the said north line of Carriage Hills Subdivision, south $35^{\circ} 35'$ west, 108 feet to a point; thence leaving the north line of Carriage Hills Subdivision, north $33^{\circ} 45'$ west, 328 feet to a point in the north margin of Hacienda Lane; thence with the said north margin, north $51^{\circ} 29'$ east, 315 feet to a point in the west margin of Old Hartford Road; thence with the said west margin, south $31^{\circ} 45'$ east 51 feet to the point of beginning, containing 1.01 acres, more or less.

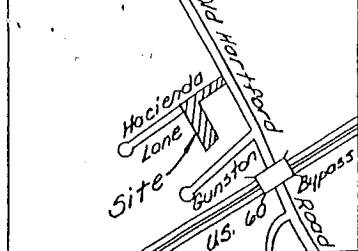

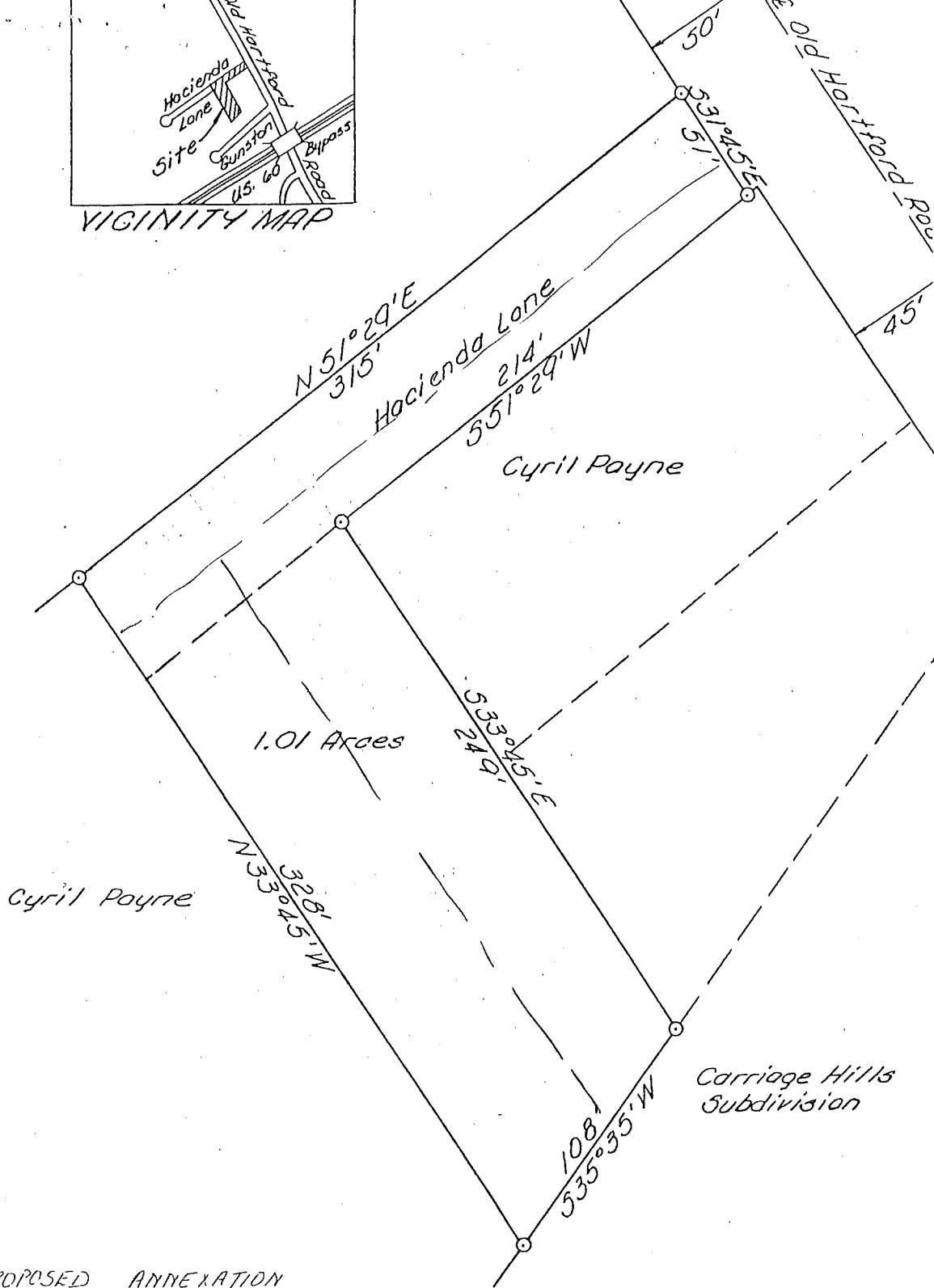
