ORDINANCE NO. 51-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING A PORTION OF THE GLENMORE DISTILLERIES PROPERTY LOCATED ON U.S. HWY 60, EAST, CONTAINING 29.9 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 28-81 heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on April 2, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly

described as follows:

BEGINNING at the southwest corner of Birkhead Avenue and U.S. 60 East (Fourth Street); said point being in the present city limits; thence northwardly 74 feet to a point in the north margin of U.S. 60 East; thence along the north right-of-way margin of U.S. 60 East 545 feet, more or less, to a point; said point being the southwest corner of the Glenmore Distilleries Company tract; thence N 34° 59' 54" W 93.09 feet; thence N 35° 00' 18" W. 169.99 feet; thence N 34° 57' 47" W 602.57 feet; thence N 34° 57' 47" W 102.04 feet; thence N 48° 47' 05" E 47.11 feet; thence N 51° 30' 50" E 165.76 feet; thence N 34° 11' 45" E 39.59 feet; thence N 65° 38' 16" E 308.19 feet; thence N 64° 34' 45" E 100.77 feet; thence N 65° 22' 31" E 152.34 feet; thence N 64° 36' 06" E 406.54 feet; thence S 40° 42' 55" E 123.53 feet; thence S 40° 42' 55" E 220.20 feet; thence N 55° 15' 39" E 100.01 feet; thence S 40° 33' 59" E 443.10 feet to a point in the north margin of U.S. 60 East; said point being the southeast corner of the Glenmore tract; thence southwardly 76 feet, more or less to a point in the south right-of-way line of U.S. 60 East; said point being 106 feet, more or less, east of the southeast corner of the Maple Heights Avenue intersection; thence westwardly with the south right-of-way line of U.S. 60 East 1,925 feet, more or less, to the point of beginning and containing 29.9 acres, more or less.
