ORDINANCE NO. 49-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2200 NEW HARTFORD ROAD, CONTAINING .82 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 21-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on March 27, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:


SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point (not marked) approximately at the Northwest corner of the old store building at the intersection of the south margin of the Hartford Road, with the East margin of the Veach Road; thence with the South margin of the Hartford Road, North 86, 12' East 54.9 feet to an iron pipe in the Western margin of the new Hartford Road, or Kentucky State Highway No. 71; thence with the Western right of way, parallel with and 43 feet West of the center line of said highway South 26, 24' East 160.58 feet to an iron pipe, opposite construction station 121 plus 50 on said highway; thence North 63, 36' East 3 feet to an iron pipe, also opposite said station; thence South 26, 24' East parallel with and 40 feet Westward from the center line of said highway passing an iron pipe at 13 feet in all 158 feet to an iron pipe 60 feet Northwest of the Northeast corner of a

tract or parcel of land, owned by William Wilson, colored; thence leaving the right of way and running parallel with the North line of said William Wilson, colored, South 75, 19' West 174.4 feet to an iron pipe in the East margin of the Veach Road; thence with the same North 5° 12' West, passing an iron pipe on the right at 100 feet, 200 feet and 300 feet, in all 325.04 feet to the beginning containing .82 acres.



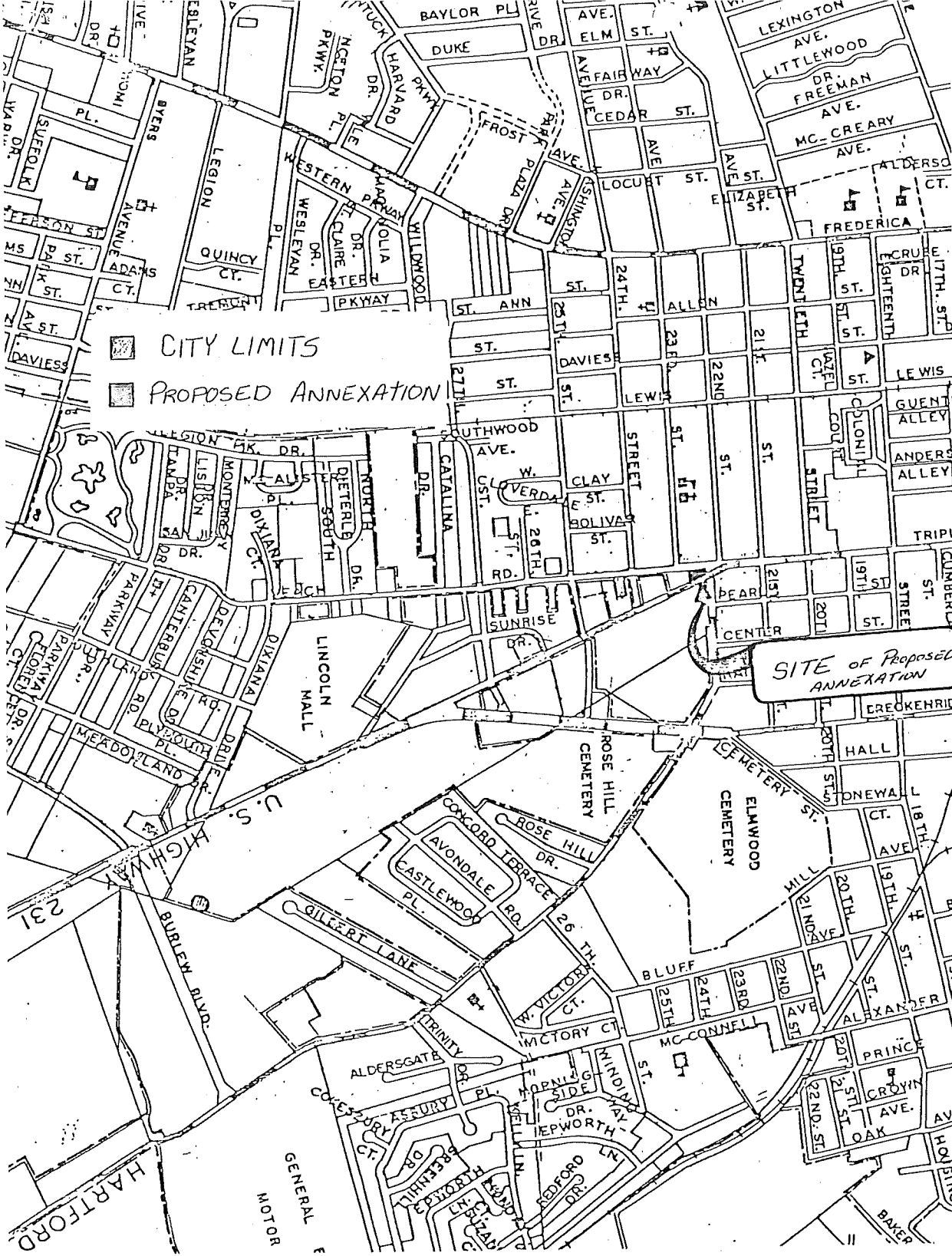
