ORDINANCE NO. 59-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED ON THE EAST SIDE OF U.S. HWY 231 ABOUT 0.4 MILES NORTH OF THE OWENSBORO BY-PASS, KNOWN AS THE HOLLAND DAIRY FOODS, INC. PROPERTY, CONTAINING 1.2 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 32-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on April 24, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.


NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the present city limits line; said point being the previous western right-of-way line of U.S. Highway N. 231; and also being approximately 1,060 feet northward, as measured along the highway construction centerline, from the northwest corner of the Byers Avenue intersection; thence northward with the present city limit 150 feet, more or less, thence N 64° 03' E 342 feet, more or less; thence S 25° 57' E 150 feet, more or less, thence S 64° 03' W 351 feet, more or less, to the point of beginning in the present city limit line, and containing 1.2 acres, more or less.



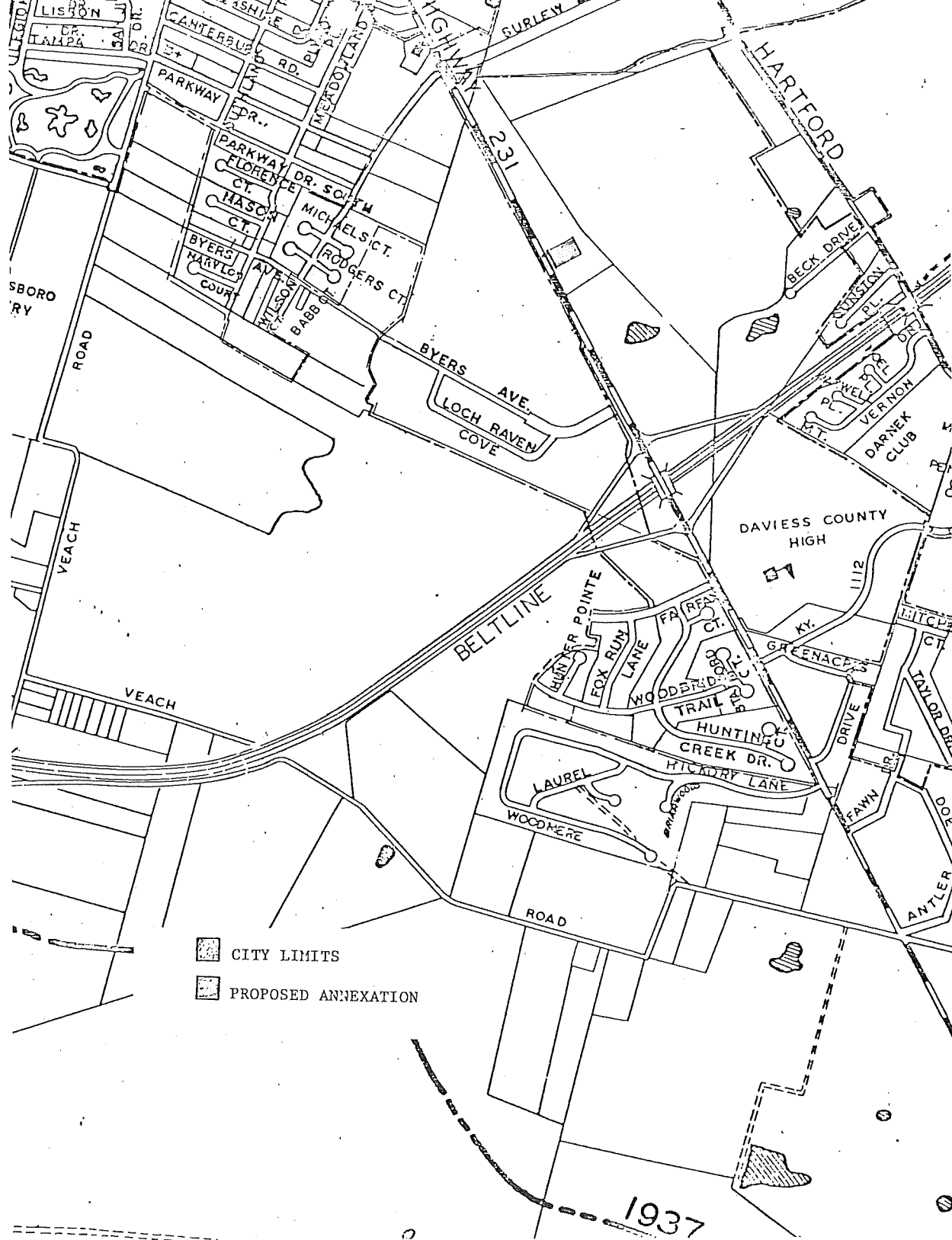
