ORDINANCE NO. 60-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOIN-ING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2212 PARRISH AVENUE, CONTAINING .35 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. <u>33-81</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>April 24</u>, <u>1981</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the south margin of Parrish Avenue and also being a point in the present city limits, said point being 490 feet, more or less, west of the southwest corner of Bosley Road; thence south 190 feet to a point; thence west 80 feet to a point; thence north 190 feet to a point in the south margin of Parrish Avenue and being in the present city limits; thence east along the south margin of Parrish Avenue 80 feet to the point of beginning and containing .35 acres, more or less.
