ORDINANCE NO. 61-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2306 PARRISH AVENUE, CONTAINING 0.97 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 35-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on May 1, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe in the south margin of Parrish Avenue, also being a point in the present city limits, said point being corner to property of the Parrish Avenue Church of Christ and being 1,345.5', more or less, west of the southwest corner of Bosley Road; thence S 9° 49' E 45.53' to an iron pipe; thence S 13° 31' E 110.7' to an iron pipe; thence S 7° 14' E 35.64' to an iron pipe common to Alvey Subdivision; thence with the property line of the Alvey Subdivision, also being the present city limits S 83° 20' W 238' to an iron pipe in the east margin of a 12-foot alley; thence with the east margin of said alley N 4° 33' W 180.80 feet to a p.k. nail in the south margin of Parrish Avenue; thence with the south margin of Parrish Avenue N 80° 39' E 215.50 feet to the point of beginning and containing 0.97 acres.

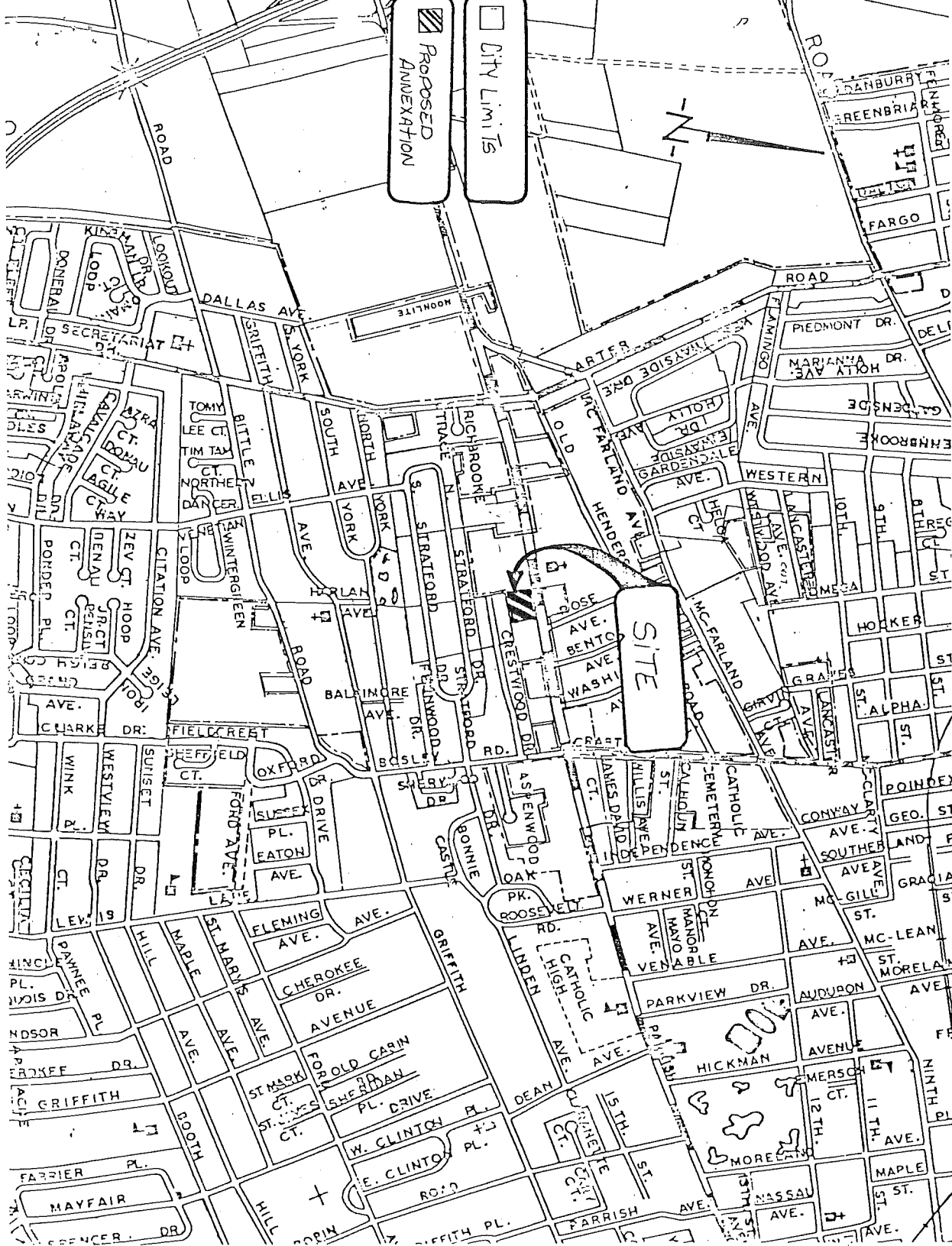
