ORDINANCE NO. 72-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2701 VEACH ROAD, CONTAINING 0.36 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 47-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on May 29, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the east margin of Veach Road, said point also being in the south margin of Twenty Seventh Street, said point also being in the present city limits line; thence with the south margin of Twenty Seventh Street north 85° 14' east 200.00 feet to a point; thence south 40° 26' east 75.33 feet to a point; thence south 83° 50' west 200.00 feet to a point; thence north 40° 26' west 80.13 feet to the point of beginning and containing 0.36 acres, more or less.

INTRODUCED AND PUBLICLY READ ON FIRST READING, this the 31st day of July 1981.



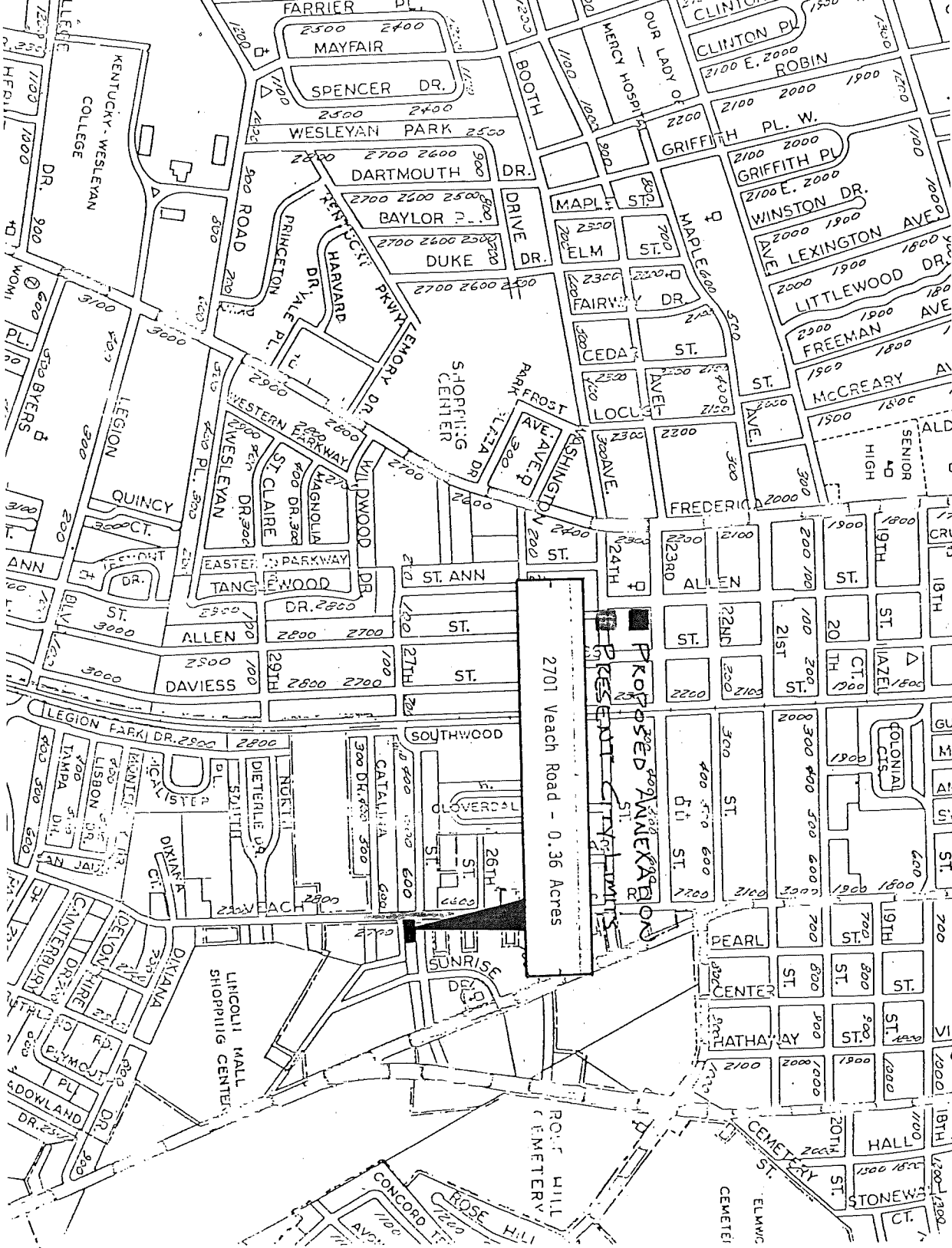
