ORDINANCE NO. 81-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED IN TAMARACK PARK SUBDIVISION, UNIT NO. 8 - CONTAINING 7.73 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 65-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 24, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:


BEGINNING at an iron pin in the east margin of Carter Road and in south line of Bernardine Ward property; thence South 75 degrees 56 minutes East 137.95 feet; North 14 degrees 41 minutes East 149.75 feet; South 75 degrees 36 minutes East 205.99 feet; South 76 degrees 11 minutes East 914.61 feet; South 13 degrees 41 minutes West 280.00 feet; North 76 degrees 11 minutes West 128.70 feet; North 80 degrees 36 minutes West 51.96 feet; north 76 degrees 11 minutes West 916.72 feet; North 71 degrees 57 minutes West 50.14 feet; North 76 degrees 11 minutes West 115.00 feet; North 14 degrees 09 minutes East 132.31 feet to the point of beginning and containing 7.73 acres, more or less.
