ORDINANCE NO. 85-81

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED IN THE 700 BLOCK OF DALTON STREET, KNOWN AS THE PRECIOUS BLOOD CHURCH PROPERTY, CONTAINING 0.90 ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 74-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on August 21, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.


NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe in the west right-of-way of Dalton Street, said point being in the present city limit line and being 120 feet south of the southwest corner of the Dalton Street/Fennmore Street intersection; thence with the present city limit, also being the west right-of-way of Dalton Street, S 5° 25' E 360 feet to an iron pipe; said point being approximately 244.23 feet northward of the north right-of-way of West Fifth Street Road; thence S 84° 35' W 108.5 feet to an iron pipe; thence N 5° 25' W 360.48 feet to an iron pipe; thence N 84° 50' E 108.5 feet to the point of beginning and containing 0.90 acre, more or less.


