ORDINANCE NO. 1-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 3924 OLD HARTFORD ROAD, CONTAINING 1.13 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 88-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on October 30, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the west right-of-way line of Old Hartford Road, said point also being in the north right-of-way line of Hacienda Lane, said point also being in the present city limits line; thence south 51° 29' east 240 feet to a point; thence north 33° 49' west 215 feet to a point; thence north 55° 11' east 234.5 feet to a point in the west right-of-way line of Old Hartford Road; thence with said right-of-way line south 36° 18' east 147 feet to the point of beginning and containing 1.13 acres, more or less.

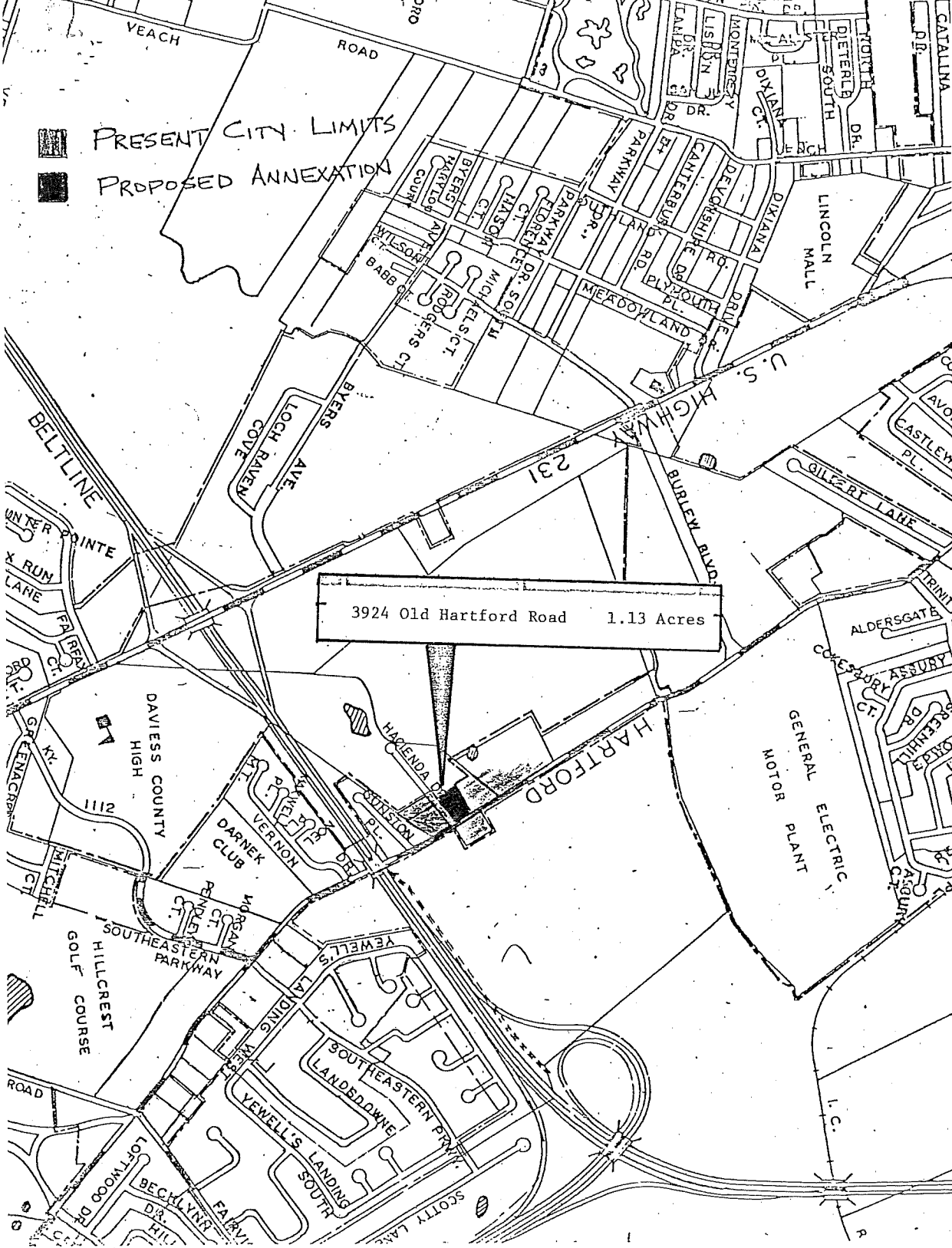
