ORDINANCE NO. 2-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCOR-PORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2002 SCHERM ROAD, CONTAINING 0.46 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. <u>87-81</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>October 30</u>, 19<u>81</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the south margin of Scherm Road, said point being approximately 190 feet west of the west margin of Christie Place, said point also being in the present city limits line; thence in a southern direction 200 feet to a point; thence south 69° 33' west 106.4 feet to a point; thence in a northern direction 200 feet to a point in the south margin of Scherm Road; thence with said margin north 69° 33' east 106.4 feet to the point of beginning and containing 0.46 acres, more or less.
