ORDINANCE NO. 3-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED IN SPRING BANKS SUBDIVISION, CONTAINING 4.64 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 86-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on October 30, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Spring Bank Drive, said point being 300 feet west of the west margin of U.S. Highway 231, said point also being in the present city limits line; thence with the north margin of Spring Bank Drive in a westward direction 509.06 feet to a point; thence north 29° 36' west 332.38 feet; thence north 60° 24' east 134.0 feet to a point; thence north 73° 33' east 344.28 feet to a point; thence south 28° 33' east 422.59 feet to the point of beginning and containing 4.64 acres, more or less.

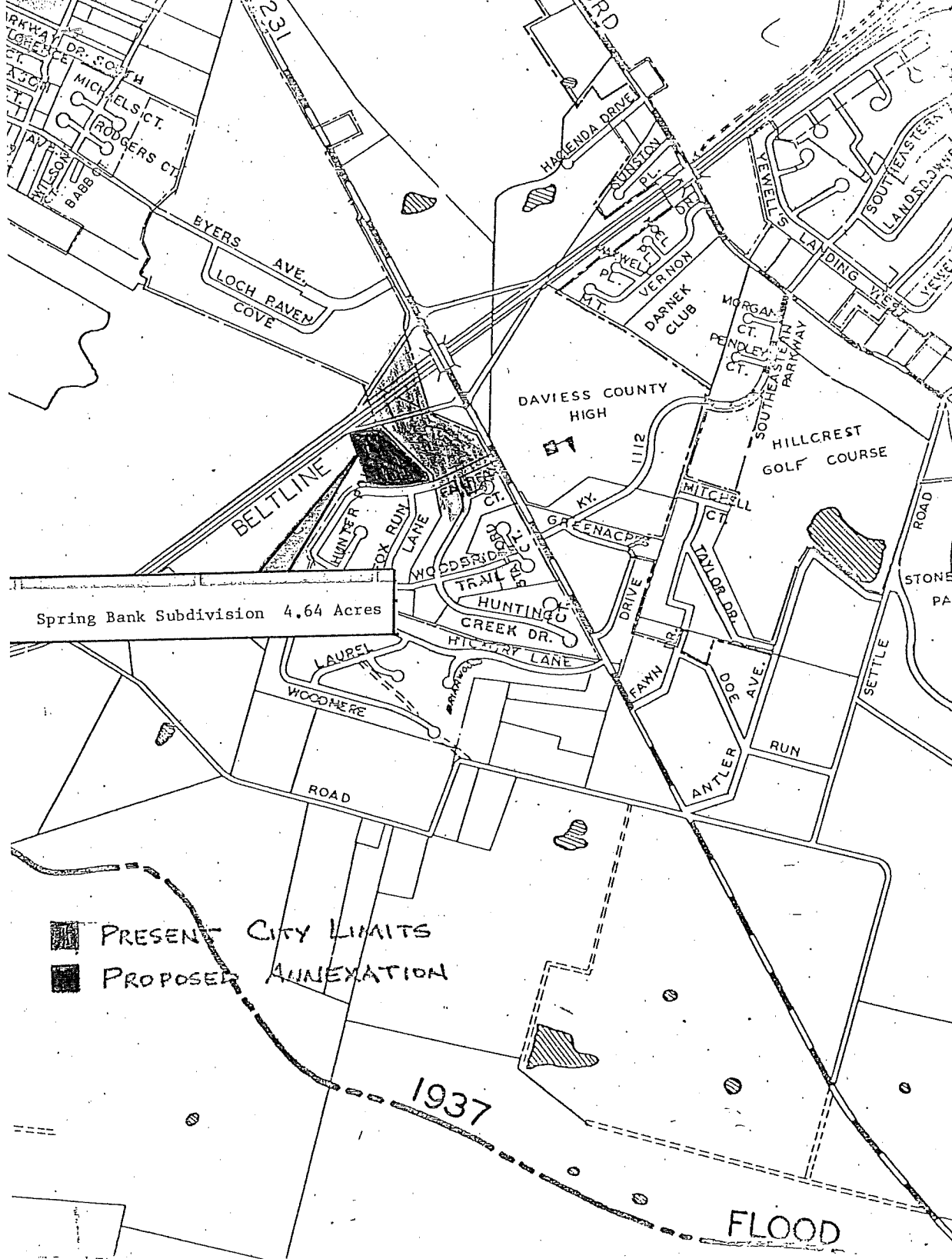
