ORDINANCE NO. 15-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING UNIT 5-D, LOT 579, IN OWEN PARK SUBDIVISION, AND MORE PARTICULARLY LOCATED AT 3340 WILSON LANE, CONTAINING 0.187 OF AN ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. 98-81, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on December 18, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a stake in the west margin of Wilson Lane, said stake being 402.00 feet south of the south margin of Byers Avenue; thence with the west margin of Wilson Lane south 22 degrees 10 minutes west 86.16 feet; thence leaving Wilson Lane north 59 degrees 29 minutes west 101.87 feet; north 19 degrees 09 minutes east 71.46 feet; south 67 degrees 50 minutes east 104.53 feet to the point of beginning and containing 0.187 of an acre, more or less.

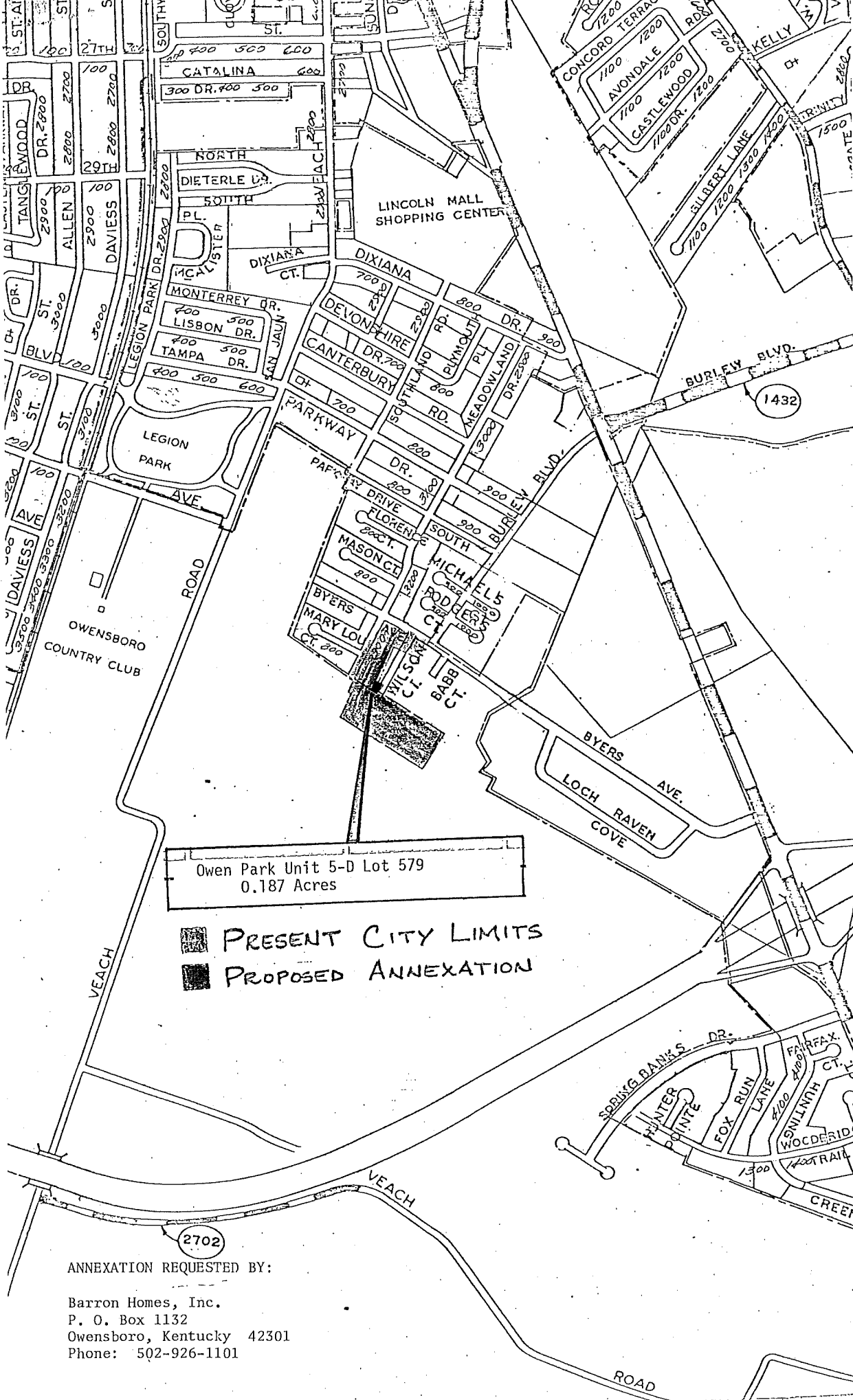
