ORDINANCE NO. 21-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2103 OLD HENDERSON ROAD, CONTAINING 0.24 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. <u>84-81</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>October 23</u>, 1981, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the north margin of Old Henderson Road, said point also being in the west margin of Washington Avenue; thence and with the north margin of Old Henderson Road in a westward direction 60 feet to a point; thence in a northward direction and crossing an 18 foot public alley 174 feet to a point in the north margin of said alley; thence with the north margin of said alley in an eastward direction 60 feet to a point in the west margin of Washington Avenue; thence with the west margin of Washington Avenue and crossing said public alley in a southern direction 174 feet to the point of beginning and containing 0.24 acres, more or less.
