ORDINANCE NO. 51-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORD, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2204 PARRISH AVENUE, CONTAINING 0.34 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. <u>26-82</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>May 4</u>, 1982, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the south margin of Parrish Avenue, said point being approximately 410 feet west of the west margin of Bosley Road, said point also being in the west margin of a north-south alley, said point also being in the present city limits line; thence with the west margin of said alley in a southerly direction 174 feet to a point; thence in a southwestwardly direction 8.5 feet to a point in the north margin of an east-west alley; thence with the north margin of said alley in a westerly direction 74 feet to a point; thence in a northerly direction 184 feet to a point in the south margin of Parrish Avenue; thence with the south margin of Parrish Avenue in an easterly direction 80 feet to the point of beginning and containing 0.34 acres, more or less.
