ORDINANCE NO. 54-82

SECRETARY OF STATE COMMONWEALTH OF KY.

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO,

KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 1103 WING AVENUE, CONTAINING 4.10 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. <u>30-82</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>May 11</u>, 19 <u>82</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> Beginning at a point in the north margin of Grimes Avenue, said point also being in the east margin of Wing Avenue, said point also being in the present city limits line; thence with the east margin of Wing Avenue, north 38° 51' west 403.70 feet to a point; thence north 53° 17' east 127.5 feet to a point; thence north 37° 46' west 132.35 feet to a point; thence north 51° 42' east 238.81 feet to a point; thence south 38° 31' east 533 feet to a point in the north margin of Grimes Avenue, said point also being in the present city limits line; thence with the north margin of Grimes Avenue, south 51° 44' west 365.36 feet to the point of beginning and containing 4.10 acres, more or less.
