ORDINANCE NO. 55-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED IN VILLA POINT SUBDIVISION, LOT NO. 1, CONTAINING 1.01 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 29-82, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on May 11, 1982, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Kentucky Highway No. 54, said point also being in line with the west margin of Plaza Point Drive, said point also being in the line of a pending annexation (Lot 2, Villa Point - First Reading Proposal, April 6, 1982, Ordinance No. 22-82); thence with the north margin of Kentucky Highway No. 54 in a southeast direction 134.63 feet to a point; thence crossing Kentucky Highway No. 54 south  $65^{\circ} 17' 45''$  west 100 feet to a point in the south margin of Kentucky Highway No. 54; thence continuing along same bearing 50 feet to a point; thence south  $65^{\circ} 42' 15''$  east 53.80 feet to a point; thence south  $22^{\circ} 32' 05''$  west 150 feet to a point, said point also being in the north margin of Villa Point Drive; thence with the north margin of Villa Point Drive, north  $65^{\circ} 42' 15''$  west 143.05 feet to a point in the east margin of Plaza Point Drive, said point also being in the present city limits line; thence crossing Plaza Point Drive along the same bearing 50 feet to a point in the west margin of Plaza Point Drive, said point also being in the line of the above mentioned pending annexation; thence with the west margin of Plaza Point Drive north  $24^{\circ} 17' 45''$  east 200 feet to a point in the south margin of Kentucky Highway No. 54; thence crossing Kentucky Highway No. 54 along the same bearing 100 feet to the point of beginning and containing 1.01 acres, more or less.

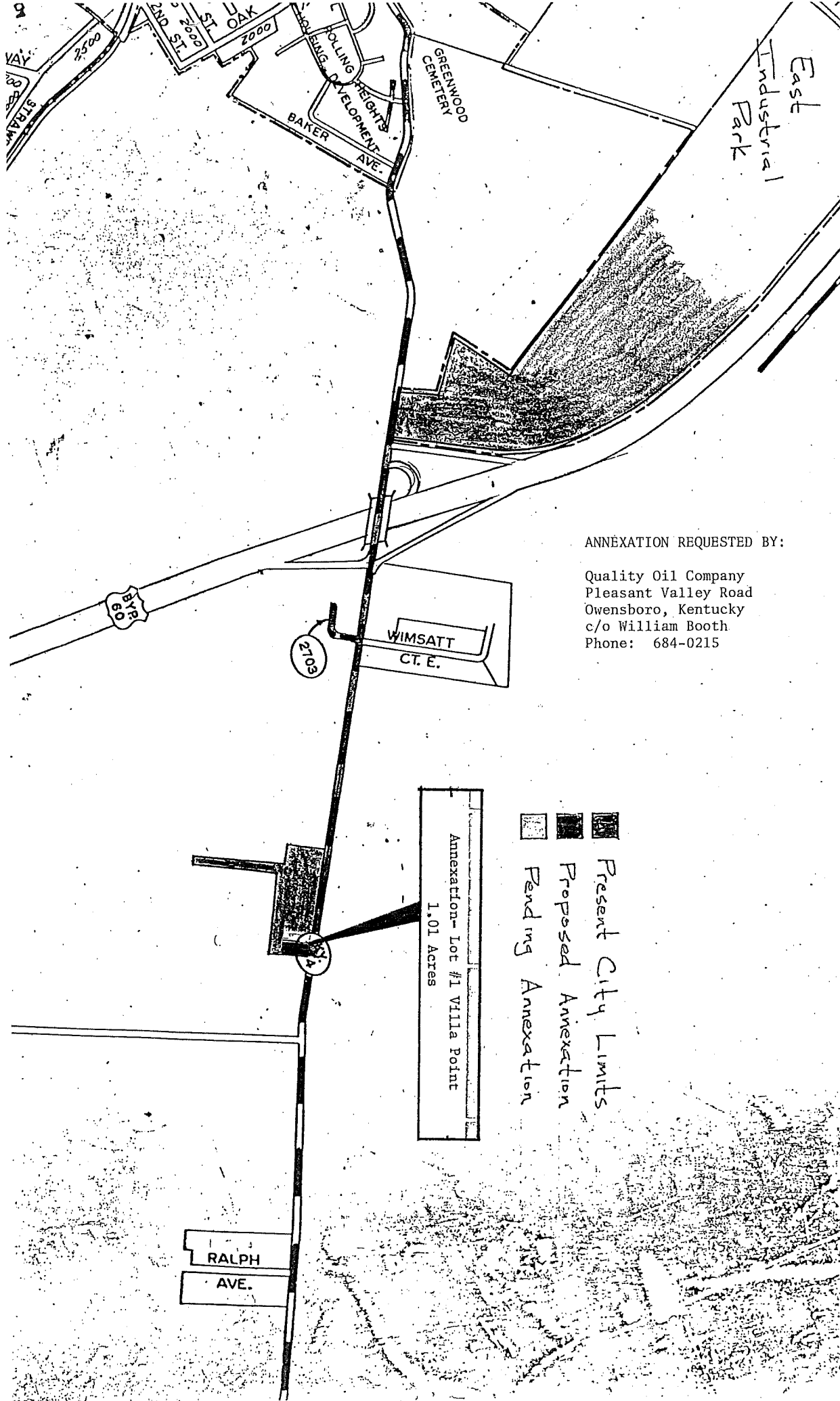
